- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 19 MARYLAND, That the Laws of Maryland read as follows:

- 17 Maryland-National Capital Park and Planning Commission may make a reciprocal
- 18 agreement for the period that it considers advisable with the District of Columbia or
- 19 a county, municipal corporation, or the Maryland-National Capital Park and
- 20 Planning Commission, within or outside the State, and establish and carry out a plan
- 21 to provide mutual aid by providing its police officers and other officers, employees,
- 22 and agents, together with all necessary equipment as provided in subsection (b) of
- 23 this section.
- 24 (2) A county, municipal corporation, or the Maryland-National Capital
- 25 Park and Planning Commission may not make a reciprocal agreement unless the
- 26 agreement provides that each party shall:
- 27 (i) waive any and all claims that are against the other parties to
- 28 the agreement and that may arise out of their activities outside their respective
- 29 jurisdictions under the agreement; and
- 30 (ii) indemnify and hold harmless the other parties to the agreement
- 31 from all claims by third parties that are for property damage or personal injury and
- 32 that may arise out of the activities of the other parties to the agreement outside their
- 33 respective jurisdictions under the agreement.
- 34 (f) The governing body of a county or municipal corporation in the State may
- 35 obtain or extend the necessary public liability insurance to cover claims that arise out
- 36 of mutual aid agreements made with another county or municipal corporation outside
- 37 the State.
- 38 (g) The police officers and other officers, agents, and employees coming into
- 39 the State under a reciprocal agreement under this section, may enforce the laws of the
- 40 State to the same extent as authorized law enforcement officers of a county or
- 41 municipal corporation in the State.

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2005.
