 4 (ii) indemnify and hold harmless the other parties to the agreement
 5 from all claims by third parties that are for property damage or personal injury and
 6 that may arise out of the activities of the other parties to the agreement outside their
 7 respective jurisdictions under the agreement.
- 8 (f) The governing body of a county or municipal corporation in the State may 9 obtain or extend the necessary public liability insurance to cover claims that arise out 10 of mutual aid agreements made with another county or municipal corporation outside 11 the State.
- 12 (g) The police officers and other officers, agents, and employees coming into 13 the State under a reciprocal agreement under this section, may enforce the laws of the 14 State to the same extent as authorized law enforcement officers of a county or 15 municipal corporation in the State.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 17 October 1, 2005.
