A BILL ENTITLED

1 AN ACT concerning

2 **Caroline County - Alcoholic Beverages - Open Containers**

3 FOR the purpose of making it a misdemeanor for a person in Caroline County to
4 possess an open container of an alcoholic beverage under certain circumstances;
5 establishing a penalty; and generally relating to open containers of alcoholic
6 beverages in Caroline County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article 2B - Alcoholic Beverages**

20 19-301.

21 (a) (1) This definition applies only in the following jurisdictions:

22 (i) Caroline County;

23 (ii) Carroll County;

24 (iii) Dorchester County;

25 (iv) Harford County;

1 (v) Montgomery County;

2 (vi) Prince George's County; and

3 (vii) Wicomico County.

4 (2) In this section "unless authorized" means the possession and
5 presentation of a written consent by the owner of the property.

6 (b) A person may not possess in an open container any alcoholic beverage, as
7 defined in this article, while:

8 (1) On the mall, adjacent parking area, or other outside area of any
9 combination of privately owned retail establishments, commonly known as a shopping
10 center, to which the general public is invited for business purposes, unless authorized
11 by the owner of the establishment;

12 (2) On an adjacent parking area or other outside area of any other retail
13 establishment, unless authorized by the owner of the establishment; or

14 (3) In any parked vehicle located on any of the places enumerated in this
15 section, unless authorized.

16 19-302.

17 Any person who violates the provisions of this subtitle is guilty of a
18 misdemeanor and upon conviction is subject to a fine not exceeding \$100.

19 19-303.

20 This subtitle applies only in the following counties:

21 (1) Allegany County;

22 (2) Baltimore County, including motorcycles located on any of the places
23 enumerated in § 19-301 of this subtitle, unless authorized;

24 (3) Calvert County;

25 (4) CAROLINE COUNTY;

26 [(4)] (5) Carroll County, including motorcycles located on any of the
27 places enumerated in § 19-301 of this subtitle, unless authorized;

28 [(5)] (6) Cecil County;

29 [(6)] (7) Charles County;

30 [(7)] (8) Dorchester County;

31 [(8)] (9) Frederick County;

- 1 [(9)] (10) Garrett County;
- 2 [(10)] (11) Harford County;
- 3 [(11)] (12) Howard County;
- 4 [(12)] (13) Montgomery County;
- 5 [(13)] (14) Prince George's County;
- 6 [(14)] (15) St. Mary's County;
- 7 [(15)] (16) Somerset County; and
- 8 [(16)] (17) Wicomico County.
