- 24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 25 MARYLAND, That the Laws of Maryland read as follows:

- 28 the Act, all the functions, powers, duties, equipment, assets, liabilities, and all the

- 1 certificated and noncertificated employees of the Baltimore City Public School System
- 2 shall be transferred to the New Baltimore City Board of School Commissioners and to
- 3 the Chief Executive Officer of the Board. If assets are not sufficient to fund liabilities
- 4 transferred, the liabilities shall be retained by the Mayor and City Council.
- 5 Additionally, during any fiscal year after Fiscal Year 1997, liability for payments at

- 20 4-114 and 4-115 of the Education Article as amended by Chapter 105 of the Acts of
- 21 1997, the Board of Public Works, for the period from July 1, 1997 through June 30,
- 22 2009, may approve State funding for capital improvements to public school buildings
- 23 in Baltimore City on property held under a clear deed and title by either the
- 24 Baltimore City Board of School Commissioners or the Mayor and City Council of
