AND BE IT FURTHER ENACTED, That the Secretary of the 27 Environment shall convene a work group consisting of representatives of the various 28 sectors of the petroleum marketing industry and representatives from appropriate 29 public and private entities to review and assess long-term funding needs of the oil 30 pollution programs in the State. Subject to § 2-1246 of the State Government Article, 31 the Department of the Environment shall report the findings and recommendations 32 of the work group to the Legislative Policy Committee, the House Environmental 33 Matters Committee, and the Senate Education, Health, and Environmental Affairs 34 Committee on or before December 31, 2009.
