AT LEAST 60 HOURS, 10 HOURS OF WHICH MUST OCCUR 11 DURING THE PERIOD BEGINNING 30 MINUTES BEFORE SUNSET AND ENDING 30 12 MINUTES AFTER SUNRISE, OF BEHIND-THE-WHEEL DRIVING PRACTICE SUPERVISED 13 BY AN INDIVIDUAL WHO: 14 HOLDS A VALID DRIVER'S LICENSE; A.
