- 6 (2) THE PLANNING COMMISSION SHALL PUBLISH THE FIRST NOTICE OF 7 THE MEETING AT LEAST 15 DAYS BEFORE THE MEETING.

- 9 DECIDED BY THE PLANNING COMMISSION WITHIN A CERTAIN PERIOD, THE PERIOD
- 10 SHALL BE STAYED FOR UP TO 30 DAYS TO ALLOW FOR THE PUBLIC NOTICE REQUIRED
