16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

17 MARYLAND, That the Laws of Maryland read as follows:

Article - State Personnel and Pensions

20 (A) THIS SECTION APPLIES TO ALL EMPLOYEES, EXCEPT TEMPORARY
21 EMPLOYEES, OF ALL UNITS IN THE EXECUTIVE BRANCH OF STATE GOVERNMENT,
22 INCLUDING ANY UNIT WITH AN INDEPENDENT PERSONNEL SYSTEM.

23 (B) AN EMPLOYEE SUBJECT TO THIS SECTION SHALL BE ENTITLED TO
24 COMPENSATORY TIME FOR MENTORING YOUTH IN A BONA FIDE MENTORING YOUTH
