SENATE JOINT RESOLUTION

- 1 A Senate Joint Resolution concerning
- Compensation to Families of Military Service Members Who Gave Their 2 3 **Lives in the Service of Our Country**
- FOR the purpose of urging the President and the Congress of the United States to compensate the families of military service members who gave their lives in the 5
- service of our country; providing that a copy of this resolution be forwarded by 6
- the Department of Legislative Services to certain individuals; and generally 7
- relating to compensation to families of military service members who gave their 8
- 9 lives in the service of our country.
- 10 WHEREAS, A recently released study by the Rand Corporation found that the
- 11 civilian families who lost loved ones in the terrorist attacks of September 11, 2001,
- 12 received an average of \$3.1 million in compensation, mostly from the government,
- 13 and that the families of firefighters and police officers killed as a result of the
- 14 terrorist attacks received an average of \$4.2 million; and
- 15 WHEREAS, The current death gratuity for survivors of military service
- 16 members killed in action is a lump sum payment of \$12,000, and the current monthly
- 17 payment to surviving spouses who do not remarry is \$967 per month, plus \$241 per
- 18 child, with a slightly higher amount received per child by surviving children of
- 19 military service members who did not have a surviving spouse; and
- 20 WHEREAS, The sacrifices made by military service members who gave their
- 21 lives in Iraq, Afghanistan, and in other locations in service of our country deserve to
- 22 be honored by increasing the present compensation to the families of those military
- 23 service members; and

- WHEREAS, The Congress of the United States is considering legislation that
- 2 would increase the compensation to the families of military service members who
- 3 gave their lives in the line of duty; now, therefore, be it
- 4 RESOLVED BY THE GENERAL ASSEMBLY OF MARYLAND, That the
- 5 General Assembly urges the President and the Congress of the United States to
- 6 adequately compensate the families of military service members who gave their lives
- 7 in the service of our country; and be it further
- 8 RESOLVED, That a copy of this Resolution be forwarded by the Department of
- 9 Legislative Services to the Honorable Robert L. Ehrlich, Jr., Governor of Maryland;
- 10 the Honorable Thomas V. Mike Miller, Jr., President of the Senate of Maryland; and
