Authorizing the creation of a State debt, the proceeds to serve as a grant to the Board of Directors of Adventure Sports Center, Inc. for the design, construction, and capital equipping of the headquarters of Adventure Sports Center, Inc., the Adventure Sports Museum, and the Whitewater Hall of Fame, located on Marsh Mountain in Garrett County.

Prior to the payment of any funds, the grantee shall provide and expend a matching fund. No part of the fund may consist of real property, in kind contributions, or funds expended prior to the effective date of this Act.

9. Description and Purpose of Grantee Organization		
<p>ASCI Mission</p> <p>The mission of ASCI is to establish an International Adventure Sports Center that is recognized as a focal point in the emerging and expanding adventure sports industry worldwide.</p> <p>The Center will work to promote, educate and facilitate participation in a wide range of adventure-based recreational activities and competitions, thereby creating a unique destination that serves to support local economic development and as a model for communities wishing to capitalize on their intrinsic natural resource base while protecting its integrity.</p> <p>ASCI Goals</p> <ul style="list-style-type: none"> • Create in Maryland an International venue for adventure activities for people with all levels of ability. • Establish a forum for education, training, competition, and public participation in a wide range of Adventure Sports. • Provide a staging area for conducting activities throughout the Region and State. • Foster economic development through expanded tourism and growth of an Adventure Sports industry benefiting the Region and the State 		

10. Description and Purpose of Project

ASCI has submitted a proposal to the State in request of two million dollars (\$2,000,000) to assist with the development and construction of the Adventure Sports Headquarters and the Adventure Sports Museum and Hall of Fame. If granted, the State's funding will be used to provide space for several critical functions for the organization including the ASCI administrative offices, guest services and all aspects of the Adventure Sports Hall of Fame and Museum.

The Adventure Sports Headquarters space and the Museum and Hall of Fame are identified as critical facilities in the organizations Master Plan. In the short term, the Hall of Fame and Museum will compliment the whitewater operations by providing an additional attraction and rentable space, while the administrative center will serve as direct support for the organizations Phase 1 operations (including the re-circulaing whitewater course, amphitheater, walking paths, picnic areas, etc.) as well as ASCI's next phase (the development of the 550 acre Fork Run Adventure Recreation Area which includes hiking, snowshoeing, mountain biking and cross country ski trails, high and low ropes courses, rock climbing, bouldering and camping sites and an orienteering venue).

In longer terms, the Adventure Sports Headquarters and the Adventure Sports Museum and Hall of Fame will stand as the focal point and “nerve center” for the entire operation thereby allowing the State to lay claim to the notion that Western Maryland is the Nations’ foremost place and source for Adventure Sports Competition, Recreation and Education.
