FISCAL AND POLICY NOTE

Senate Bill 152 (Chairman, Education, Health, and Environmental Affairs Committee) (By Request – Departmental – Labor, Licensing, and Regulation)

Education, Health, and Environmental Affairs

Economic Matters

Occupational and Professional Licensing - Disciplinary Actions - Grounds

This departmental bill lowers the standard for specified disciplinary actions against applicants, licensees, and certificate holders for the five design professional boards which regulate architects, certified interior designers, landscape architects, professional engineers, and professional land surveyors and property line surveyors by removing the requirement that an individual "knowingly" committed a violation. The bill also broadens the scope of violations for which these boards may take a disciplinary action against these individuals by making a violation of any regulation, adopted by each regulated industry's respective board, including the code of ethics, to be the basis for a disciplinary action.

Fiscal Summary

State Effect: This bill would not materially affect the finances of the five design professional boards within the Department of Labor, Licensing, and Regulation (DLLR).

Local Effect: None.

Small Business Effect: DLLR has determined that this bill has minimal or no impact on small business (attached). Legislative Services concurs with this assessment.

Analysis

Current Law: The State, on behalf of each design board, must prove that an applicant, licensee, or certificate holder knowingly (*i.e.*, consciously and intentionally) violated a statute or the code of ethics.

Background: DLLR advises that current statute makes it difficult for the State to prove that applicants, licensees, or certificate holders consciously and intentionally avoided their legal obligations; the bill's changes would allow the five boards to better protect the interest of consumers by making it easier for the boards to take disciplinary action against unethical applicants, licensees, or certificate holders. DLLR further advises that removing "knowingly" from statute for the design boards will make these boards' violation statutes consistent with other licensing boards housed within the department.

DLLR advises that each design board has enacted regulations that compel applicants, licensees, and certificate holders to adhere to minimum standards of professional conduct; the bill's changes would provide each board with the necessary authority to enforce regulations as well as the code of ethics. DLLR further advises that amending statute to reflect that violations of any regulation adopted by the design professional boards are subject to disciplinary action makes the boards' disciplinary authority consistent with other boards housed within the department.

DLLR currently licenses 5,600 architects, 280 certified interior designers, 785 landscape architects, 14,500 professional engineers, and 900 professional land surveyors and property line surveyors.

Additional Information

Prior Introductions: This bill was introduced as SB 176 in the 2004 session. It was passed by the Senate but received an unfavorable report from the House Economic Matters Committee.
