Register of Wills - Salary

This bill increases the limit on the maximum salary that the Board of Public Works (BPW) may set for a register of wills from \$85,000 to \$98,500. The bill's provisions will apply at the beginning of the next following term of office.

Fiscal Summary

State Effect: General fund revenues would decrease by \$203,500 in FY 2007, due to the December 1, 2006 effective date of anticipated salary increases. Future year revenue decreases reflect annualization.

Analysis

Current Law: A register of wills is entitled to receive an annual salary of not more than \$85,000. While the permissible range of salaries is set by statute, BPW determines the annual salary of each register of wills.

In determining the salary of a register of wills, BPW is required to consider:

- the population of the county determined by the last official U. S. census;
- the dollar volume of total fees and taxes collected and excess fees turned over to the State for each of the preceding five years by the office of the register for which the salary is being fixed; and
- other pertinent data which have relation to the reasonableness of the salary in relation to the work done and volume handled by the office.

The Maryland Constitution provides that the salary or compensation of any public officer may not be increased or diminished during a term of office except for those whose full term of office is fixed by law and exceeds four years.

Background: Registers of wills are elected officials. The register of wills in each jurisdiction is responsible for the administration of estates by providing proper forms and direction, assisting and advising any person who requests assistance in the preparation of any form for administrative probate, admitting wills to probate and issuing letters of administration, auditing accounts, and maintaining accurate records of all estate matters.

The registers collect the inheritance tax, which is applied to the receipt of property from a decedent's estate.

The registers retain 25% of inheritance tax revenues as a commission, with the remaining 75% remitted to the general fund. To the extent that inheritance tax and other revenues (including probate fees) received by the registers of wills exceed the operating costs of the registers' offices, the excess inheritance tax collections are remitted back to the general fund. The registers' revenues (probate fees and the unremitted portion of the inheritance tax) and expenditures are not included in the State budget.

Chapter 294 of 2002 increased the maximum salary of the registers of wills from \$75,000 to \$85,000, a 13% increase. **Exhibit 1** sets forth the maximum salary levels since 1986.

State Expenditures: Exhibit 2 shows the current and projected salaries of the 24 registers. This analysis assumes that the Board of Public Works would increase the salaries of the registers who currently earn the current maximum of \$85,000 to \$98,500, a 16% increase, and increase the salaries of the other clerks by 16%.

The total annual salary increase is \$303,813. Including fringe benefits, general fund expenditures would increase by \$203,471 in fiscal 2007 or \$348,808 annually. The salary increases would take effect December 1, 2006, the beginning of the next term of office for the elected registers.

Exhibit 3 shows a detailed history of actual register salaries for each jurisdiction since 1987.
