FISCAL AND POLICY NOTE

Senate Bill 214

(The President) (By Request – Administration)

Budget and Taxation

Health and Government Operations

Department of State Police - Transfer of the Senator William H. Amoss Fire, Rescue, and Ambulance Fund to the Maryland Emergency Management Agency

This Administration bill transfers the functions, powers, duties, assets, and liabilities of the Senator William H. Amoss Fire, Rescue, and Ambulance Fund from the Department of State Police to the Maryland Emergency Management Agency (MEMA).

Fiscal Summary

State Effect: None. The requirements of this bill could be handled with the existing budgeted resources of MEMA. Removing the fund from the State Police would not significantly impact finances or operations.

Local Effect: None.

Small Business Effect: A small business impact statement was not provided by the Administration in time for inclusion in this fiscal note. A revised fiscal note will be issued when the Administration's assessment becomes available.

Analysis

Current Law: The State Fire, Rescue, and Ambulance Fund, established in 1985, was named after Senator William H. Amoss in 1998. The fund was established to promote:

- the delivery of effective emergency services to the citizens;

- increased financial support for emergency services companies by local governments; and
- the continued financial viability of volunteer emergency services companies.

As a condition to receiving financial assistance from the fund, each county must participate in the Maryland Fire Incident Reporting System and Ambulance Information System, as appropriate.

Background: MEMA is responsible for coordinating the State response to any major emergency or disaster. This includes supporting local governments as needed or requesting and coordinating assistance with the Federal Emergency Management Agency.

MEMA is organized within the Maryland Military Department. In an emergency situation MEMA may answer directly to the Governor.

MEMA gets its authority from Article 5 of the Annotated Code. This Article creates MEMA and authorizes the political subdivisions of the State to create emergency management offices of their own. Article 5 also gives the Governor emergency powers – such as temporarily waiving State laws that may interfere with emergency response operations.

MEMA staff consists of approximately 40 emergency management professionals. The agency coordinates various federal programs including Superfund Amendments Reauthorization Act, Hazardous Material Transportation Act, and Chemical Stockpile Emergency Preparedness Program.

The fund has revenues and expenditures of \$10 million, annually. The Governor's allowance shows anticipated allocations to counties as follows in fiscal 2006:
