#### 6. Purpose of Bill

The purpose of the Bill is to provide funding for the redevelopment of 1701 N. Ellamont Street into a community day care center that will service a number of at-risk children in the community. We currently provide services to fifty children and families who reside in one of Baltimore City communities most highly affected by urban blight social toxins, e.g., poor educational opportunities, high crime and violence, drug infestation, joblessness, and inherent threats to overall physical health. This Bill will enable children to receive early childhood education programs in a physical environment that is safe, clean, healthy, and child-friendly which adheres to standards for early learning; preparing school readiness by implementing the early childhood programs according to the Maryland State Department of Education and the National Association for the Education of Young Children; and enabling Baltimore City to fulfill the requirement of full-day kindergarten for all children and pre-K for children at-risk by the 2007-2008 school year as mandated in the Bridge to Excellence in Public School Act and requirements under the President's No Child Left Behind (NCLB).

### 9. Description and Purpose of Grantee Organization

Sandi's Learning Center, Inc., was founded in November 2003. It is an expansion of the successful business, Sandi's Learning Day Care, LLC that was founded in September 2002. In our community, we are a highly visible organization that can be described as a specialist in the field of childcare services. Our goal is to provide quality early care and education programs that will produce better outcomes for children. In order to help attain the project's goals, Sandi's Learning Center will continue its partnership with Baltimore City Child Care Resource Head Start and the The Department of Social Service Family Investment Program. In addition, by December, 2005, construction will be 100% completed; by March 2006, Sandi's Learning Center will be accredited by the Maryland State Department of Education and the National Association for the Education of Young Children; and a partnership will be formed with the Maryland State Department of Education.

## 10. Description and Purpose of Project

Sandi's Learning Center, Inc. will provide a much-needed service to a community lacking in child development, family development, and community development services. The goal is to build a 15,200 feet facility that will provide a full service learning facility to address the educational and development needs of the community. Specifically, Sandi's Learning Center, Inc. will provide the following:

- Quality Birth-to-Five Child Development Services Our curriculum includes skills for school readiness and they address key child development areas of physical well being, social and emotional development, approaches to learning, language development, and cognition.
- Quality After-School Care Services Children who would otherwise be "latchkey" children will receive supervision, educational services, and structured fun activities.
- Family Development Services Workshops and resources offered to aid families.
- Community Development Services On-going workshop, hands-on training in early childhood development, technology, professional development and resources offered to aid members in the community
- Professional Development Services for Early Childhood Educators- We will continue our partnership with Baltimore Child Care Resource Center Head Start Program and the Department of Social Services Family Investment Program. In addition, we will continue to train, motivate and, monitor our instructors continuously.

The short- term benefit to the community will be having a stable and ever present business entity addressing the specific needs of the community. The long- term benefit will be a generation of children acquiring basic skills and motivated and encouraged to pursue higher education. The center will have the capacity to serve 225 children and their families.

Moreover, in this wavering economy, jobs and business opportunities will be created. Initially, an additional 12 jobs will be created (teachers, teachers' aids, chief cook), but numerous positions will become available: janitorial staff, technical assistance and marketing staff.
