AMENDMENT NO. 1

On page 1, in the sponsor line, strike "Delegate Hubbard" and substitute "<u>Delegates Hubbard</u>, Barve, Benson, Boteler, Bromwell, Costa, Donoghue, Elliott, Frank, Hammen, Kach, Kohl, Kullen, Mandel, McDonough, Morhaim, Murray, Nathan-Pulliam, Oaks, Pendergrass, Rudolph, and V. <u>Turner</u>"; strike beginning with "requiring" in line 10 down through "circumstances;" in line 11; and in line 12, after "reimbursement;" insert "<u>requiring the Department of Health and Mental Hygiene to provide for a certain dedicated staff person for certain purposes under certain circumstances;".</u>

AMENDMENT NO. 2

On page 2, in line 2, after "ENROLLEES" insert "<u>REPRESENTATIVE OF THE ENTIRE MEDICAID POPULATION</u>"; in lines 6 and 9, in each instance, strike the brackets; in line 6, strike "NOT MORE THAN FIVE PROVIDERS"; in line 9, strike "NOT MORE THAN TWO HOSPITAL"; in line 23, strike "AND"; and after line 24, insert:

"J. LOW-INCOME INDIVIDUALS AND INDIVIDUALS RECEIVING BENEFITS THROUGH THE TEMPORARY ASSISTANCE FOR NEEDY FAMILIES PROGRAM; AND

K. <u>INDIVIDUALS RECEIVING SUBSTANCE ABUSE</u> TREATMENT SERVICES;".

AMENDMENT NO. 3

On page 4, in line 19, strike "10" and substitute "<u>5</u>"; strike beginning with "IS" in line 21 down through "THAT" in line 22 and substitute "<u>REASONABLY</u>"; in line 24, strike "SUBSUBPARAGRAPHS" and substitute "<u>SUBSUBPARAGRAPH</u>"; in line 25, strike "AND 3"; and strike in their entirety the lines 29 through 36 and substitute:

- "2. A MEMBER OF THE COMMITTEE WHO IS AN ENROLLEE IS ENTITLED TO REIMBURSEMENT FOR:
- A. EXPENSES FOR PERSONAL AND DEPENDENT CARE INCURRED DURING THE MEETING AND DURING TRAVEL TIME TO AND FROM THE MEETING;
- B. EXPENSES FOR COGNITIVE SUPPORTS RELATED TO THE MEETING; AND
- 3. ON REQUEST, THE DEPARTMENT SHALL PROVIDE FOR A DEDICATED DEPARTMENT STAFF PERSON:
- A. TO REVIEW MEETING MATERIALS WITH ENROLLEE MEMBERS IN ADVANCE OF A MEETING BY TELEPHONE OR IN PERSON; AND
- B. TO PROVIDE REFERRALS TO ADVOCACY ORGANIZATIONS.".
