## AMENDMENTS TO HOUSE BILL NO. 1430

(First Reading File Bill)

## AMENDMENT NO. 1

On page 1, in line 3, after the first "of" insert "<u>repealing a certain requirement that certain compensation be included in the calculation of the retirement allowance of certain individuals;</u>"; in line 19, after the semicolon insert "clarifying certain definitions;"; after line 21, insert:

"BY repealing and reenacting, with amendments,

Article - Education

<u>Section 6-116(d)</u>

Annotated Code of Maryland

(2004 Replacement Volume and 2005 Supplement)";

and in line 26, strike "and 29-115" and substitute "29-115, and 37-201 (d)".

## AMENDMENT NO. 2

On page 2, after line 3, insert:

## "Article - Education

6-116.

- (d) A fellow shall receive an annual compensation that consists of:
- (i) A salary at the level and step the fellow would have received according to the salary scale of the employer school system; and
  - (ii) A \$20,000 annual stipend.

#### **APP**

- (2) [The compensation described under paragraph (1) of this subsection shall be included in the State calculation for retirement purposes under Titles 22 and 23 of the State Personnel and Pensions Article.
- (3)] For each year of the fellow's placement in a receiving school, the Department shall issue a grant to the receiving school system in an amount that covers:
  - (i) The annual stipend; and
- (ii) If the fellow's salary at the level and step on the salary scale of the receiving school system as of July 1 is less than that of the level and step on the salary scale of the employer school system, the amount of the difference.
- [(4)] (3) The receiving school system shall reimburse the employer school system for:
  - (i) The salary of the fellow;
  - (ii) The annual stipend; and
- (iii) The fringe benefit costs associated with the fellow's annual salary including the stipend.".

#### AMENDMENT NO. 3

On page 2, in line 28, after "THE" insert "<u>STATUTORY</u>"; and in the same line, strike "OF 5% PER YEAR" and substitute "<u>EARNED ON MEMBER CONTRIBUTIONS IN THE MEMBER'S SYSTEM</u>,".

#### AMENDMENT NO. 4

On page 5, in line 29, strike "or"; and in line 31, after "program" insert "; OR

(III) MORE THAN A TOTAL OF 5 YEARS OF SERVICE CREDIT IN THE EMPLOYEES' PENSION SYSTEM FOR EMPLOYMENT AS A POSTSECONDARY SCHOOL TEACHER".

# HB1430/484861/1 APP Amendments to HB 1430 Page 3 of 3

On pages 5 and 6, strike in their entirety the lines beginning with line 32 on page 5 through line 2 on page 6, inclusive.

On page 6, in line 3, strike "(5)" and substitute "(4)"; and strike beginning with "FOR" in line 19 down through "SYSTEM" in line 21 and substitute "MAY NOT PURCHASE MORE THAN 5 YEARS OF SERVICE CREDIT IN THE TEACHERS' PENSION SYSTEM FOR EMPLOYMENT AS A POSTSECONDARY SCHOOL TEACHER".

## AMENDMENT NO. 5

On page 9, after line 29, insert:

"<u>37-101.</u>

(d) "Contributory system" means a State or local retirement or pension system[, other than the State Contributory Employees' Pension System, the State Contributory Law Enforcement Officers' Pension System, or the State Contributory Teachers' Pension System,] under which member contributions are deducted from all compensation.".
