AMENDMENT NO. 1

On page 1, in line 2, strike "Site"; in line 6, after "<u>zone</u>" insert "<u>, or under certain</u> <u>circumstances, an area within a certain distance</u>"; in the same line, after "station" insert "<u>, and certain</u> <u>commercial establishments</u>"; in line 8, after "licenses;" insert "<u>providing that certain holders of Class</u> <u>B beer, wine and liquor licenses in Prince George's County are not precluded from having an interest</u> in <u>Class B or Class BLX licenses elsewhere in Prince George's County; providing that a certain limit</u> <u>on the maximum number of Class B beer, wine and liquor licenses does not apply to issuances of</u> <u>Class B licenses under certain circumstances; providing for a certain exception;</u>"; and in line 17, strike "9-217(f)(5)" and substitute "<u>9-217(d) and (f)(5)</u>".

AMENDMENT NO. 2

On page 2, after line 3, insert:

"(d) This section does not apply to licenses issued under the provisions of 6-201(r)(2) [or], (5), OR (6) or § 7-101 of this article.";

in line 22, strike "or"; and strike in their entirety lines 23 and 24 and substitute:

"D. EXCEPT FOR METRORAIL STATIONS IN LEGISLATIVE DISTRICT 24, A TRANSIT DISTRICT OVERLAY ZONE FOR A METRORAIL STATION, OR IF THERE IS NOT A TRANSIT DISTRICT OVERLAY ZONE FOR A METRORAIL STATION, AN AREA WITHIN 2,000 FEET OF THE PROPERTY LINE OF PROPERTY OWNED OR LEASED BY METRO SERVING A METRORAIL STATION IN THE COUNTY; OR

E. <u>CAPITAL PLAZA COMMERCIAL AREA CONSISTING OF</u> <u>COMMERCIAL ESTABLISHMENTS WITHIN THE AREA BOUNDED BY THE</u> <u>BALTIMORE-WASHINGTON PARKWAY ON THE WEST AND NORTHWEST, MARYLAND</u>

ROUTE 450 ON THE SOUTH, AND COOPER LANE ON THE EAST AND NORTHEAST; OR". On page 3, strike beginning with "An" in line 5 down through "areas" in line 9 and substitute "<u>THE PROVISIONS OF THIS PARAGRAPH DO NOT PRECLUDE A HOLDER OF A CLASS B</u> <u>LICENSE ISSUED UNDER THIS PARAGRAPH FROM HAVING AN INTEREST IN CLASS B</u> <u>OR CLASS BLX LICENSES ELSEWHERE IN PRINCE GEORGE'S COUNTY</u>"; in line 12, strike "(ii)2" and substitute "(ii)2B"; and in line 21, strike "applies" and substitute "<u>DOES NOT APPLY</u>".
