# AMENDMENTS TO HOUSE BILL NO. 1381 (First Reading File Bill)

#### AMENDMENT NO. 1

On page 1, strike beginning with "Public" in line 2 down through "Tuition" in line 3 and substitute "<u>Tuition Affordability Act of 2006</u>"; strike beginning with "making" in line 6 down through "contingency;" in line 7 and substitute "<u>limiting, for a certain academic year, an increase in the tuition that may be charged to a resident undergraduate student at a certain public senior higher education institution; establishing a Commission to Develop the Maryland Model for Funding Higher Education; providing for the composition of the Commission; providing for the appointment of the chairman of the Commission; requiring the Commission to review certain reports and options and make certain recommendations relating to the establishment of a consistent and stable funding mechanism to ensure accessibility and affordability at certain public institutions of higher education in Maryland; requiring the Commission to submit a certain report to the Governor and General Assembly on or before a certain date; providing for the staffing of the Commission; providing for the termination of a certain provision of this Act;".</u>

## AMENDMENT NO. 2

On page 2, strike in their entirety lines 27 through 31, inclusive, and substitute:

"SECTION 2. AND BE IT FURTHER ENACTED, That, notwithstanding any other provision of law, for the academic year beginning in the fall of 2006 only, the St. Mary's College of Maryland Board of Trustees may not approve, and St. Mary's College of Maryland may not impose, an increase in the tuition charged for the academic year to a resident undergraduate student more than 4.8% over the amount charged for tuition at St. Mary's College of Maryland in the preceding 2005-2006 academic year.

- (iii) The Maryland Chamber of Commerce;
- (iv) The Greater Washington Board of Trades;
- (v) The Greater Baltimore Committee; and
- (vi) The President's Roundtable, Inc.; and

(16) Three members of the public, appointed jointly by the President of the Senate and the Speaker of the House, one of whom must have experience in business, finance, or management.

(c) The chairman of the Commission shall be appointed jointly by the President of the Senate and the Speaker of the House.

(d) The Commission shall review the report issued by Van de Water Consulting, Inc., hired by the Maryland Higher Education Commission to develop an effective statewide framework for higher education funding as recommended in the 2004 Maryland State Plan for Postsecondary Education.

(e) The Commission shall review options and make recommendations relating to the establishment of a consistent and stable funding mechanism to ensure accessibility and affordability while at the same time promoting policies to achieve national eminence at all of Maryland's public

institutions of higher education.

(f) The Commission shall report its findings and recommendations to the Governor and, in accordance with § 2-1246 of the State Government Article, to the General Assembly on or before December 31, 2007.

(g) The staff for the Commission shall be provided and coordinated by the Department of Legislative Services. The Department of Budget and Management, the Maryland Higher Education Commission, and the University System of Maryland shall also assign staff to assist the Commission.

SECTION 4. AND BE IT FURTHER ENACTED, That Section 3 of this Act shall take effect July 1, 2006, and shall remain effective for a period of 1 year and 10 months and, at the end of May 1, 2008, with no further action required by the General Assembly, Section 3 of this Act shall be abrogated and of no further force and effect.".

## AMENDMENT NO. 3

On page 2, in line 32, strike "3." and substitute "<u>5.</u>"; in the same line, strike "2" and substitute "<u>4</u>"; and in line 33, strike "July" and substitute "June".
