On page 1, in line 4, strike "Treasurer's Office" and substitute "Department of Housing and Community Development"; in lines 8 and 9, in each instance, strike "Treasurer" and substitute "Department"; in line 10, after "notification;" insert "requiring the Department to receive loan applications from minority business enterprises and forward loan applications to lenders; requiring the Department to require minority business enterprises to notify the Department concerning final loan disposition; requiring the Department to report annually to the Governor, the Treasurer, and the General Assembly on the overall performance of the Linked Deposit Program;"; strike beginning with "gives" in line 13 down through "institution" in line 14 and substitute "<u>is a certain percent below current market rates or a certain index</u>"; in line 15, strike "certain financial institutions" and substitute "<u>the Treasurer</u>"; and in line 20, after "Treasurer" insert "<u>and the Department</u>".
