AMENDMENT NO. 1

On page 2 of the bill, in line 23, strike "SUBSECTION (E) OF".

On page 5 of the bill, in line 8, strike "SUBSECTION (C) OF".

AMENDMENT NO. 2

In the Education, Health, and Environmental Affairs Committee Amendments (SB0391/144736/1), strike Amendment Nos. 4 and 5 in their entirety.

On page 3, in line 1, after "EQUIVALENTS" insert "HELD"; in line 2, strike "INCLUDING" and substitute "OR ASSETS THAT ARE EVIDENCED BY A SECURITY INTEREST, INCLUDING AN"; in the same line, strike "RECEIPTS" and substitute "RECEIPT ISSUED BY THE FINANCIAL INSTITUTION OR BY AN INDEPENDENT TRUSTEE IN THE NAME OF THE UNIT"; strike beginning with "THE" in line 3 down through "COMMERCE" in line 5 and substitute "§ 9-109 OF THE COMMERCIAL LAW ARTICLE"; in line 7, after "REMEDIED;" insert "AND

3. <u>IDENTIFY THE SOLICITATION OR CONTRACT</u> NUMBER FOR WHICH THE SECURITY INTEREST IS PROVIDED;";

in line 17, strike "THAT"; strike beginning with "IS" in line 18 down through "2." in line 20 and substitute "THAT"; in line 20, after "THE" insert "CONTRACTOR OR"; in line 21, strike "AND" and substitute:

"2. THAT MAY INCLUDE THE GRANTING OF A MORTGAGE OR DEED OF TRUST ON REAL PROPERTY LOCATED WITHIN THE STATE IF SATISFACTORY TO THE UNIT;";

strike in their entirety lines 22 through 27, inclusive, and substitute:

- "3. FOR WHICH THE FACE AMOUNT OF THE MORTGAGE
 OR DEED OF TRUST ON THE REAL PROPERTY LOCATED WITHIN THE STATE DOES
 NOT EXCEED 75% OF THE CONTRACTOR'S OR INDIVIDUAL SURETY'S EQUITY
 INTEREST IN THE PROPERTY; AND
- 4. FOR WHICH A MORTGAGE OR DEED OF TRUST ACCEPTED UNDER THIS SUBSECTION IS RECORDED BY AN OFFICIAL DESIGNATED BY THE UNIT WHERE THE REAL PROPERTY IS SITUATED IN ACCORDANCE WITH § 3-103 OF THE REAL PROPERTY ARTICLE; OR";

in line 30, strike "AND"; and in line 33, after "PROVIDED" insert "; AND

- 3. <u>CONTAIN A PAYOUT CLAUSE IF THAT DEFAULT</u> CANNOT BE REMEDIED.
- (F) ANY ASSET LISTED UNDER SUBSECTION (E)(5) OF THIS SECTION SHALL BE PLEDGED ONLY FOR THE INTENDED SECURITY AND MAY NOT BE PLEDGED FOR

- (4) THE INDIVIDUAL SURETY PROVIDES A UCC-1 FILING SECURITY INTEREST TO THE PUBLIC BODY FOR ONE OR MORE OF THE ASSETS LISTED IN ITEM (5)(I) THROUGH (IV) AND (VI) OF THIS SUBSECTION AT THE TIME THE BOND IS FURNISHED; AND";

in line 28, strike "(2)" and substitute "(5)"; in lines 28 and 29, strike "OF THE FOLLOWING"; in line 30, after "SOLICITATION" insert "INCLUDING"; in line 32, after "EQUIVALENTS" insert "HELD"; in line 33, strike "INCLUDING" and substitute "OR ASSETS THAT ARE EVIDENCED BY A SECURITY INTEREST, INCLUDING AN"; in the same line, strike "RECEIPTS" and substitute "RECEIPT ISSUED BY THE FINANCIAL INSTITUTION OR BY AN INDEPENDENT TRUSTEE IN THE NAME OF THE PUBLIC BODY"; and strike beginning with "THE" in line 34 down through "AND" in line 36 and substitute "§ 9-109 OF THE COMMERCIAL LAW ARTICLE;".

On page 6 of the bill, in line 2, after "REMEDIED;" insert "AND
