AMENDMENT NO. 1

On page 1, in the sponsor line, strike beginning with "Delegate" down through "Delegates" and substitute "Delegates Marriott,"; in the sponsor line, strike "and Rosenberg" and substitute "Rosenberg, Bartlett, Boschert, Bozman, Cardin, C. Davis, Elmore, Healey, Heller, Hixson, Howard, Kaiser, King, McKee, Myers, Patterson, Ramirez, and Ross"; in line 10, after "students;" insert "requiring the operator to conduct certain outreach programs to provide information and encourage student recruitment and participation from each county in the State;"; and in line 18, after "Act" insert "and certain other federal laws".

AMENDMENT NO. 2

On page 3, in line 1, after "MEETS" insert "AT LEAST TWO OF"; after line 8, insert:

"(4) HAVING A DISABILITY;";

and in lines 9, 11, 12, 13, 15, and 17, strike "(4)", "(5)", "(6)", "(7)", "(8)", and "(9)", respectively, and substitute "(5)", "(6)", "(7)", "(8)", "(9)", and "(10)", respectively.

AMENDMENT NO. 3

On page 4, after line 29, insert:

- "(E) THE OPERATOR SHALL CONDUCT AN OUTREACH PROGRAM FOR EACH LOCAL EDUCATION AGENCY IN THE STATE TO:
- (1) PROVIDE INFORMATION TO THE LOCAL EDUCATION AGENCY ABOUT THE PROGRAM; AND
 - (2) ENCOURAGE STUDENT RECRUITMENT AND PARTICIPATION

FROM EACH COUNTY IN THE STATE.".

AMENDMENT NO. 4

On page 5, in line 19, after "TO" insert ":

<u>(1)</u>";

and in line 21, after "STATE" insert "; AND

(2) THE REQUIREMENTS OF 20 U.S.C. § 1400, ET SEQ. AND § 504 OF THE REHABILITATION ACT OF 1973, 29 U.S.C. § 794".

AMENDMENT NO. 5

On page 7, in line 20, after "(B)" insert "(1) SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION,"; in lines 23 and 27, strike "(C)" and "(D)", respectively, and substitute "(2)" and "(C)", respectively; strike beginning with the first "TO" in line 25 down through "YEAR" in line 26; and after line 26, insert:

"(3) THE TOTAL AMOUNT OF FUNDS APPROPRIATED UNDER THIS SUBSECTION MAY NOT EXCEED \$10 MILLION FOR ANY FISCAL YEAR.".
