# AMENDMENTS TO SENATE BILL NO. 882

(First Reading File Bill)

## AMENDMENT NO. 1

On page 1, in line 2, strike "Delinquency"; strike beginning with the second "the" in line 3 down through "Council" in line 9 and substitute "an Advisory Council to the Children's Cabinet; establishing the purpose of the Council"; in lines 9 and 16, in each instance, strike "juvenile delinquency" and substitute "at-risk youth"; in line 11, strike "and duties"; in lines 11 and 12, strike "requiring the Governor to" and substitute "providing that it is the intent of the General Assembly that the Governor"; in line 14, strike "Coordinating Council" and substitute "Governor's Office for Children"; in line 19, strike "2-601 through 2-605" and substitute "2-501 through 2-504"; in the same line, strike "6." and substitute "5."; and in line 20, strike "Delinquency".

## AMENDMENT NO. 2

On page 2, in line 2, strike "6." and substitute "<u>5.</u>"; in lines 2 and 7, in each instance, strike "DELINQUENCY"; in lines 4 and 12, strike "2-601." and "2-602.", respectively, and substitute "<u>2-501.</u>" and "<u>2-502.</u>", respectively; in line 9, after "SYSTEM" insert "<u>AND TO HELP MAKE THEM READY FOR ADULTHOOD BY AGE 21</u>"; in line 10, in each instance, strike "COORDINATING" and substitute "<u>ADVISORY</u>"; strike beginning with "ON" in line 10 down through "PROGRAMS" in line 11 and substitute "<u>TO THE CHILDREN'S CABINET</u>"; after line 11, insert:

"(D) "3-YEAR PLAN" MEANS THE 3-YEAR PLAN DEVELOPED BY THE CHILDREN'S CABINET ESTABLISHING PRIORITIES AND STRATEGIES FOR THE COORDINATED DELIVERY OF SERVICES FOR CHILDREN AND FAMILIES.";

in line 13, strike "A COORDINATING" and substitute "<u>AN ADVISORY</u>"; and strike beginning with "ON" in line 13 down through "PROGRAMS" in line 14 and substitute "<u>TO THE CHILDREN'S CABINET</u>".

## AMENDMENT NO. 3

On pages 2 and 3, strike beginning with the first "THE" in line 15 on page 2 down through "PROGRAMS." in line 13 on page 3 and substitute "<u>THE PURPOSE OF THE ADVISORY</u> COUNCIL IS TO MAKE RECOMMENDATIONS TO THE CHILDREN'S CABINET ON:

- (1) METHODS FOR MEETING THE POLICY AND PROGRAM GOALS OF THE STATE FOR INTEGRATED CHILDREN AND FAMILY PROGRAMS;
- (2) COORDINATING STATE PROGRAMS WITH PROGRAMS OPERATED BY LOCAL GOVERNMENTS, LOCAL MANAGEMENT BOARDS, AND PRIVATE GROUPS;
- (3) <u>BUILDING CAPACITY TO SERVE YOUTHS IN THEIR COMMUNITIES</u>
  AND AT HOME;
- (4) REDUCING RELIANCE ON INSTITUTIONS AS THE PRIMARY MODE OF INTERVENTION FOR AT-RISK YOUTH OFFENDERS;
  - (5) PROMOTING POSITIVE OUTCOMES FOR YOUTHS;
- (6) FUNDING PRACTICES THAT PREVENT JUVENILE CRIMES AND DELINQUENCY; AND
  - (7) REDUCING DISPROPORTIONATE MINORITY CONFINEMENT.".

On page 3, in line 14, strike "2-603." and substitute "2-503.".

## AMENDMENT NO. 4

On pages 3 and 4, strike beginning with "AT-RISK" in line 15 on page 3 down through "BOARDS." in line 2 on page 4 and substitute "AN AT-RISK YOUTH PREVENTION AND DIVERSION PROGRAM MAY BE:

- (1) (I) COMMUNITY-BASED;
  - (II) SCHOOL-BASED;
  - (III) NEIGHBORHOOD-BASED; OR
  - (IV) FAITH-BASED; AND

## (2) NONRESIDENTIAL.

(B) AT-RISK YOUTH PREVENTION AND DIVERSION PROGRAMS SHALL BE COORDINATED, MONITORED, AND SUPPORTED BY LOCAL MANAGEMENT BOARDS.".

## AMENDMENT NO. 5

On page 4, in lines 3, 6, 11, and 26, strike "(B)", "(C)", "(D)", and "(E)", respectively, and substitute "(C)", "(D)", "(E)", and "(F)", respectively; in lines 3 and 4, strike "COORDINATING COUNCIL" and substitute "GOVERNOR'S OFFICE FOR CHILDREN"; strike beginning with "FUNDS" in line 4 down through "PROGRAMS" in line 5 and substitute "FUNDING FOR THE AT-RISK YOUTH PREVENTION AND DIVERSION PROGRAM"; in line 6, strike "COORDINATING COUNCIL" and substitute "GOVERNOR'S OFFICE FOR CHILDREN"; in line 7, strike "CONVENE" and substitute "DEMONSTRATE THAT THE LOCAL MANAGEMENT BOARD HAS CONVENED"; in line 11, strike "PLANNING GROUP" and substitute "MANAGEMENT BOARD"; in the same line, after "SHALL" insert "AS PART OF THE PREVENTION ELEMENT OF THE 3-YEAR PLAN"; in line 31, after "EVALUATE" insert "AT-RISK YOUTH PREVENTION AND DIVERSION"; and in line 32, strike "LOCAL" and substitute "AT-RISK YOUTH PREVENTION AND DIVERSION".

# AMENDMENT NO. 6

On page 5, in line 1, after "MEASURE" insert "<u>AT-RISK YOUTH PREVENTION AND DIVERSION</u>"; in line 2, strike "QUARTERLY" and substitute "<u>FISCAL AND PROGRAM</u>"; in line 4, strike "2-604." and substitute "<u>2-504.</u>"; strike beginning with "(A)" in line 5 down through "2-605." in line 21; in line 22, strike "COORDINATING COUNCIL" and substitute "<u>GOVERNOR'S OFFICE FOR CHILDREN</u>"; in line 25, strike "DELINQUENCY"; after line 26, insert:

## "SECTION 2. AND BE IT FURTHER ENACTED, That:

(1) it is the intent of the General Assembly that the Governor shall include at least \$10,000,000 in the fiscal year 2008 State budget and, in the State budget for each fiscal year thereafter, shall include sufficient funds to maintain support for the programs implemented under this Act; and
