D. <u>THAT AREA OF ELECTION DISTRICT 1, PRECINCT 7,</u> AS THAT ELECTION DISTRICT AND THAT PRECINCT EXISTED ON JANUARY 1, 2001, THAT IS SOUTH OF A LINE THAT RUNS ALONG THE CENTER OF PHILADELPHIA ROAD
