AMENDMENTS TO SENATE BILL NO. 922
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 7, after “county;” insert “providing that certain defined areas of Harford County for purposes of the issuance of Class BDR licenses do not include the corporate boundaries of the City of Havre de Grace;”.

AMENDMENT NO. 2

On page 3, strike beginning with “, regardless” in line 37 down through “County” in line 38 and substitute “IF THE RESTAURANT FOR WHICH THE LICENSE IS SOUGHT IS LOCATED ANYWHERE IN:

A. THE DEVELOPMENT ENVELOPE THAT IS DESCRIBED IN THE 2004 MASTER PLAN AND LAND USE ELEMENT PLAN ADOPTED BY COUNTY COUNCIL BILL 04-23; OR

B. ELECTION DISTRICT 1, PRECINCTS 1, 3, 4, 5, 6, 10, 16, AND 1-45, AS THAT ELECTION DISTRICT AND THOSE PRECINCTS EXISTED ON JANUARY 1, 2001;

C. THAT AREA OF ELECTION DISTRICT 1, PRECINCT 2, AS THAT ELECTION DISTRICT AND THAT PRECINCT EXISTED ON JANUARY 1, 2001, THAT IS SOUTH OF A LINE THAT RUNS ALONG THE CENTER OF PHILADELPHIA ROAD BEGINNING AT THE HARFORD COUNTY-BALTIMORE COUNTY BOUNDARY LINE AND ENDING AT THE INTERSECTION WITH OLD MOUNTAIN ROAD; OR

D. THAT AREA OF ELECTION DISTRICT 1, PRECINCT 7, AS THAT ELECTION DISTRICT AND THAT PRECINCT EXISTED ON JANUARY 1, 2001, THAT IS SOUTH OF A LINE THAT RUNS ALONG THE CENTER OF PHILADELPHIA ROAD

(Over)

BEGINNING AT OLD MOUNTAIN ROAD AND ENDING AT WINTER’S RUN, WHICH IS THE CREEK THAT FORMS THE EASTERN BOUNDARY OF PRECINCT 7 OF ELECTION DISTRICT 1”.

AMENDMENT NO. 3

On page 5, after line 4, insert:

“(VII) THE AREAS OF HARFORD COUNTY DESCRIBED IN SUBPARAGRAPHS (IV) AND (V) OF THIS PARAGRAPH MAY NOT BE CONSTRUED TO INCLUDE THE CORPORATE BOUNDARIES OF THE CITY OF HAVRE DE GRACE.”.
