(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with the second "Motor" in line 2 down through "Requirements" in line 3 and substitute "Motorized Minibikes - Regulation"; strike beginning with "altering" in line 4 down through "change" in line 22 and substitute "authorizing local authorities to establish a permit program and a permit fee for motorized minibikes; requiring a person who sells a motorized minibike to inform the buyer in writing that certain driving restrictions apply; defining "motorized minibike"; repealing a certain definition".

On pages 1 and 2, strike in their entirety the lines beginning with line 30 on page 1 through line 23 on page 2, inclusive, and substitute:

AMENDMENT NO. 2

On page 3, in line 9, strike "A MOTORCYCLE" and substitute "<u>SUBJECT TO REGISTRATION UNDER TITLE 13 OF THIS ARTICLE</u>"; in line 10, strike "INCLUDES" and substitute "<u>DOES NOT INCLUDE</u>"; strike beginning with "AND" in line 12 down through "ADMINISTRATION" in line 14 and substitute "<u>OR</u>

(3) A FARM TRACTOR";

and after line 26, insert:

"<u>15-112.</u>

- (a) [In this section, "minibike":
 - (1) Means a motor vehicle that:
 - (i) Has a saddle for the use of the rider;
 - (ii) <u>Is designed to travel on not more than three wheels in contact with the</u>
- ground; and
- (iii) Is not subject to registration under Title 13 of this article; and
- (2) Does not include a farm tractor.
- (b)] Any dealer or agent or employee of a dealer, any vehicle salesman, or any other person who sells a MOTORIZED minibike shall inform the buyer [that the use of a] IN WRITING THAT A MOTORIZED minibike MAY NOT BE DRIVEN on a highway [may be illegal] IN THE STATE.

[(c)] (B) Any dealer or agent or employee of a dealer, any vehicle salesman, or any other person who sells a MOTORIZED minibike shall inform the buyer IN WRITING that local law, ordinance, and regulation may limit the use of the MOTORIZED minibike.

<u>25-102.</u>

- (a) The provisions of the Maryland Vehicle Law do not prevent a local authority, in the reasonable exercise of its police power, from exercising the following powers as to highways under its jurisdiction:
- (15) Requiring a MOTORIZED minibike[, as defined in § 15-112(a) of this article, to be registered TO BE PERMITTED BY THE LOCAL AUTHORITY, and imposing a [registration] PERMIT fee;".
