AMENDMENTS TO HOUSE BILL NO. 923
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 14, after “level” insert “and a list of the rates paid to certain substitute teachers in certain categories”.

AMENDMENT NO. 2

On page 2, in line 22, strike “(I)”; in line 23, after “(C)(1)” insert “OR (C)(2)”; strike beginning with “ON” in line 23 down through “YEAR” in line 27 and substitute “THAT INCLUDES:”

(I) THE PERIOD OF TIME IN WHICH THE INDIVIDUAL HAS TO COMPLETE THE EDUCATIONAL REQUIREMENTS; AND

(II) THE DATES ON WHICH THE INDIVIDUAL MUST PROVIDE EVIDENCE OF THE INDIVIDUAL’S PROGRESS TOWARD COMPLETION OF THE EDUCATIONAL REQUIREMENTS TO THE BOARD OR THE BOARD’S DESIGNEE”;

in line 29, after “SUBMIT” insert “TO THE PRINCE GEORGE’S COUNTY HOUSE AND SENATE DELEGATIONS:”

(1)”;

and in line 31, strike “TO THE PRINCE GEORGE’S COUNTY HOUSE AND SENATE DELEGATIONS” and substitute “; AND”

(2) A LIST OF THE RATES PAID TO SUBSTITUTE TEACHERS IN EACH REGION, AT EACH SCHOOL, AND AT EACH EDUCATIONAL LEVEL”.

AMENDMENT NO. 3

On page 3, in line 23, strike “(I)”;

in line 24, after “(C)(1)” insert “AND (C)(2)”; strike beginning with “ON” in line 24 down through “YEAR” in line 28 and substitute “THAT INCLUDES:”

(I) THE PERIOD OF TIME IN WHICH THE INDIVIDUAL HAS TO COMPLETE THE EDUCATIONAL REQUIREMENTS; AND

(II) THE DATES ON WHICH THE INDIVIDUAL MUST PROVIDE EVIDENCE OF THE INDIVIDUAL’S PROGRESS TOWARD COMPLETION OF THE EDUCATIONAL REQUIREMENTS TO THE BOARD OR THE BOARD’S DESIGNEE”;

in line 30, after “SUBMIT” insert “TO THE PRINCE GEORGE’S COUNTY HOUSE AND SENATE DELEGATIONS:”

and in line 32, strike “TO THE PRINCE GEORGE’S COUNTY HOUSE AND SENATE DELEGATIONS” and substitute “; AND
