AMENDMENT NO. 1

AMENDMENT NO. 2

On page 1, in line 6, after "years;" insert "requiring the State Department of Education to update a certain geographic cost of education index (GCEI) at certain times; requiring the Depart ment to submit a certain proposed GCEI adjustment to the Governor and General Assembly and to recommend certain legislation at certain times;".

AMENDMENT NO. 3

On page 2, in lines 28 and 29, strike "2008" and "2009", respectively, and substitute " $\underline{200}$ 9" and " $\underline{2010}$ ", respectively.

On page 3, in lines 1, 2, and 3, strike "2010", "2011", and "2012", respectively, and subst itute "2011", "2012", and "2013", respectively.

BY SEPTEMBER 1, 2009, AND EVERY 3 YEARS THEREAFTER, THE DEPARTME NT SHALL UPDATE THE GCEI ADJUSTMENT USING:

1. THE MOST CURRENT DATA AVAILABLE; AND

THE SAME METHODOLOGY SET FORTH IN THE REPORT ENTITLED "ADJUSTI NG FOR GEOGRAPHIC DIFFERENCES IN THE COST OF EDUCATIONAL PROVISION IN MARYLAND (DECEMBER 31, 2003)".

(II) 1.

THE DEPARTMENT SHALL SUBMIT THE PROPOSED UPDATED GCEI ADJUST MENT TO THE GOVERNOR AND GENERAL ASSEMBLY BY SEPTEMBER 1 OF THE YE AR IN WHICH IT IS UPDATED.

2.

THE DEPARTMENT SHALL RECOMMEND LEGISLATION IN THE FIRST LEGISL ATIVE SESSION FOLLOWING SUBMISSION OF THE UPDATED GCEI ADJUSTMENT T HAT:

A. CODIFIES THE UPDATED GCEI ADJUSTMENT; AND

REQUIRES THAT THE GCEI ADJUSTMENT BE USED TO ADJUST STATE AID IN THE FISCAL YEAR THAT BEGINS ON JULY 1 OF THAT YEAR.".
