## AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Vallario" and substitute "Vallario, Bartlett, Boschert, Bozman, Cryor, C. Davis, Elmore, Gilleland, Goodwin, Gordon, Healey, Howard, Marriott, McKee, Patterson, Conroy, Krebs, Miller, Parrott, and Walkup"; in line 6, strike "and energy aggregators or brokers"; and strike line 14 in its entirety and substitute "providing for the carryforward of certain tax credits;".

## AMENDMENT NO. 2

On page 2 , strike in their entirety lines 23 through 29, inclusive; and in line 30 , strike "(4)" and substitute "(3)".

On page 3 , in line 17, strike "(5)" and substitute "(4)".

On page 4 , in line 4 , strike " 10 -year" and substitute " 5 -YEAR"; and in line 17 , strike "ONE-TENTH" and substitute "ONE-FIFTH".

On pages 4 and 5 , strike in their entirety the lines beginning with line 19 on page 4 through line 3 on page 5 , inclusive.

## AMENDMENT NO. 3

On page 5, in line 4, strike "(D)" and substitute "(C)"; in line 7, strike the colon; in line 8, strike "(I)"; in line 9, strike "; OR" and substitute a period; strike in their entirety lines 10 and 11 ; in line 15 , strike " 10 -YEAR" and substitute " 5 -YEAR"; in line 18 , strike " 10 TH " and substitute " 5 TH"; in line 24 , strike " 10 " and substitute " $\underline{5}$ "; in line 27 , strike " $\$ 10,000,000$; AND" and substitute " $\$ 2,500,000$."; strike in their entirety lines 28 through 33, inclusive; in line 34 , strike "(I)"; and in line 36 , strike " $\$ 100,000,000$ " and substitute " $\$ 25,000,000$ ".

## AMENDMENT NO. 4

On page 6 , strike in their entirety lines 1 through 3, inclusive; in line 8 , strike " $5 \%$ " and substitute " $10 \%$ "; in lines 23 and 31 , strike " $(\mathrm{E})$ " and " $(\mathrm{F})$ ", respectively, and substitute "(D)" and "(E)", respectively; in lines 24 and 28, in each instance, strike the bracket; strike beginning with "OTHERWISE" in line 28 down through "EXCESS" in line 30; and in line 36, strike "2009" and substitute "2007 AND EACH YEAR THEREAFTER".
