and in lines 29 and 32, strike "(5)" and "(6)", respectively, and substitute "(1)" and "(2)", respectively.

AMENDMENT NO. 4

On page 5, in lines 5, 8, 11, 13, 15, 18, and 22, strike "(7)", "(8)", "(9)", "(10)", "(B)", "(C)", and "(D)", respectively, and substitute "(3)", "(4)", "(5)", "(6)", "(6)", "(6)", "(H)", and "(D)", respectively; and strike beginning with "ON" in line 23 down through "AGENCY" in line 26 and substitute "(10)" ACCORDANCE WITH THE PROCEDURES IN § 11-312 OF THIS TITLE".
