AMENDMENT NO. 2

On page 2, strike beginning with "THE" in line 8 down through "(II)" in line 10 and substitute "<u>SIGNIFICANT</u>"; in line 10, after "<u>SYMPTOMS</u>" insert "<u>THAT REQUIRE THE ASSESSMENT OF OR TREATMENT BY QUALIFIED MEDICAL PERSONNEL</u>"; strike beginning with "HAVING" in line 16 down through "AND" in line 17 and substitute "<u>THAT REQUIRE THE ASSESSMENT OF OR TREATMENT BY QUALIFIED MEDICAL PERSONNEL</u>;"; in line 18, after "SECLUSION" insert "; AND

(7) SUICIDE ATTEMPTS";

in line 19, after "(B)" insert "(1)"; in line 20, after "SHALL" insert "<u>ATTEMPT TO</u>"; in lines 23, 24, 25, and 27, strike "(1)", "(2)", "(3)", and "(4)", respectively, and substitute "(I)", "(III)", "(III)", and "(IV)", respectively; in line 24, strike "THAT MAY RESULT IN A CHANGE IN CONDITION"; in line 26, after "CONSEQUENCE" insert "<u>THAT REQUIRES THE ASSESSMENT OF OR TREATMENT BY QUALIFIED MEDICAL PERSONNEL</u>"; and after line 27, insert:

"(2) IF A RESIDENTIAL TREATMENT CENTER SENDS A NOTICE TO AN INDIVIDUAL UNDER PARAGRAPH (1) OF THIS SUBSECTION, THE INDIVIDUAL MAY SEND A WRITTEN NOTICE TO THE RESIDENTIAL TREATMENT CENTER INSTRUCTING THE RESIDENTIAL TREATMENT CENTER THAT:
