(I) THE INDIVIDUAL WAIVES THE NOTIFICATION REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION; OR

(II) THE INDIVIDUAL ONLY REQUIRES NOTIFICATION UNDER THE CIRCUMSTANCES SPECIFIED IN WRITING BY THE INDIVIDUAL.";
