AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Hixson" and substitute "<u>Hixson, Bartlett,</u> <u>Boschert, Bozman, Cryor, C. Davis, Elmore, Gilleland, Goodwin, Gordon, Heller, Howard, Kaiser,</u> <u>King, Marriott, McKee, Myers, and Patterson</u>"; in line 2, strike "New"; in line 4, strike "that opens and operates" and substitute "<u>operating</u>"; and in line 9, strike "new".

AMENDMENT NO. 2

On page 2, in line 3, strike "WAIT STAFF" and substitute "<u>WAITSTAFF</u>"; in line 12, strike "IN" and substitute "<u>UNDER</u>"; in the same line, after "MAY" insert "<u>ONLY</u>"; and in line 28, strike "5TH" and substitute "<u>3RD</u>".

AMENDMENT NO. 3

On page 2, in line 4, after "(B)" insert "<u>(1)</u>"; in line 5, strike "THAT" and substitute "<u>MAY</u> <u>CLAIM A CREDIT AGAINST THE STATE INCOME TAX IF THE INDIVIDUAL OR</u> <u>CORPORATION:</u>

<u>(I)</u>";

in line 6, strike "MAY CLAIM A CREDIT AGAINST THE STATE INCOME TAX," and substitute "ON OR AFTER JULY 1, 2006; OR

(II) ON OR AFTER JULY 1, 2006, CONTINUES TO OPERATE A RESTAURANT WITH A MICROBREWERY LICENSE IN AN ARTS AND ENTERTAINMENT DISTRICT THAT WAS OPENED BEFORE JULY 1, 2006.";

strike in their entirety lines 7 and 8 and substitute:

"(2)THE TAX CREDIT UNDER THIS SECTION MAY BE CLAIMED:
(I)(I)FOR AN INDIVIDUAL OR CORPORATION THAT OPENS AND
OPERATES A RESTAURANT IN AN ARTS AND ENTERTAINMENT DISTRICT, FOR 5
CONSECUTIVE TAXABLE YEARS BEGINNING WITH THE FIRST TAXABLE YEAR THAT
THE TAXPAYER OPENS AND OPERATES THE RESTAURANT; OR

(II) FOR AN INDIVIDUAL OR CORPORATION THAT CONTINUES TO OPERATE A RESTAURANT WITH A MICROBREWERY LICENSE IN AN ARTS AND ENTERTAINMENT DISTRICT THAT WAS OPENED BEFORE JULY 1, 2006, FOR 5 CONSECUTIVE TAXABLE YEARS BEGINNING WITH THE TAXABLE YEAR BEGINNING AFTER DECEMBER 31, 2005.".
