On page 1, in line 9, after "requiring" insert "that on or before a certain date"; and in line 10, after "polysomnography;" insert "providing that certain licensing provisions do not apply to students practicing polysomnography under certain circumstances;".

AMENDMENT NO. 2

On page 3, in line 5, after "DISTURBANCES" insert "<u>UNDER THE SUPERVISION OF A LICENSED PHYSICIAN</u>"; and in line 7, strike "DIAGNOSING AND TREATING" and substitute "ASSISTING A LICENSED PHYSICIAN IN THE DIAGNOSIS AND TREATMENT OF".

AMENDMENT NO. 3

On page 4, in line 13, strike "AND"; in line 14, strike "AN ORAL OR NASAL DEVISE" and substitute "MONITORING THE EFFECTS A NASAL DEVICE, USED"; in the same line, strike "THAT" and substitute ", HAS ON SLEEP PATTERNS PROVIDED THAT THE DEVICE"; in line 15, after "TRACHEA" insert "; AND

- 17. MONITORING THE EFFECTS AN ORAL DEVICE, USED TO TREAT SLEEP APNEA, HAS ON SLEEP PATTERNS, PROVIDED THAT:
 - A. THE DEVICE DOES NOT EXTEND INTO THE TRACHEA;
- B. <u>A DENTIST HAS EVALUATED THE STRUCTURES OF</u> THE PATIENT'S ORAL AND MAXILLOFACIAL REGION FOR PURPOSES OF FITTING;
 - <u>C.</u> <u>A DENTIST MADE OR DIRECTED THE MAKING OF THE</u>

ORAL DEVICE; AND

D. A DENTIST DIRECTS THE USE OF THE ORAL DEVICE.

and in lines 16 and 19, strike "(G)" and "(H)", respectively, and substitute "(H)" and "(I)", respectively.

AMENDMENT NO. 4

On page 7, in line 27, before "EXCEPT" insert "(A)"; in the same line, after "SUBTITLE," insert "ON OR AFTER OCTOBER 1, 2009,"; and after line 29, insert:

"(B) THIS SECTION DOES NOT APPLY TO A STUDENT ENROLLED IN AN EDUCATION PROGRAM UNDER § 14-5C-09(C)(3) OF THIS SUBTITLE WHILE PRACTICING POLYSOMNOGRAPHY IN THAT PROGRAM.".
