AMENDMENTS TO HOUSE BILL NO. 1278

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, before "Release" insert "Child Abuse and Neglect -"; strike beginning with "Release" in line 2 down through "Abuse" in line 3 and substitute "Disclosure of Information"; in line 6, after "neglect;" insert "repealing a provision authorizing the director or the Secretary to disclose specific information concerning child abuse or neglect under certain circumstances; repealing a provision prohibiting the director or the Secretary from disclosing the file relating to an allegedly abused or neglected child; repealing a provision requiring the Secretary, in consultation with the local directors of social services, to develop a certain form;"; strike beginning with "of" in line 6 down through "Resources" in line 7 and substitute "or the director"; in line 9, after "neglect;" insert "authorizing certain individuals to file with the circuit court a motion for a protective order to limit further dissemination of certain information;"; in the same line, strike "confidentiality" and substitute "disclosure"; and strike beginning with "records" in line 9 down through "reports" in line 10 and substitute "information".

AMENDMENT NO. 2

On page 2, strike beginning with "a" in line 15 down through "SUFFERED" in line 16.

AMENDMENT NO. 3

On pages 2 and 3, strike beginning with the opening bracket in line 33 on page 2 down through "(e)" in line 14 on page 3.

On page 3, in line 14, strike the brackets; in the same line, strike "SUBJECT TO SUBSECTION (B) OF THIS SECTION, THE"; in line 20, after "neglector;" insert "OR"; strike beginning with the semicolon in line 22 down through "child" in line 25; strike beginning with "(f)" in line 29 down through "(H)" in line 34 and substitute "(E)"; in line 35, strike "LOCAL"; and strike beginning with the second "OF" in line 35 down through "SERVICES" in line 36.

AMENDMENT NO. 4

On page 4, in line 2, after "DISSEMINATION" insert ", <u>UNLESS LIMITED BY COURT</u> ORDER UNDER PARAGRAPH (3) OF THIS SUBSECTION,"; and after line 15, insert:

"(3) THE SECRETARY, THE DIRECTOR, AN ATTORNEY FOR THE CHILD, OR AN ATTORNEY FOR A PARENT OF THE CHILD MAY FILE WITH THE CIRCUIT COURT A MOTION FOR A PROTECTIVE ORDER UNDER THE MARYLAND RULES TO LIMIT FURTHER DISSEMINATION OF INFORMATION DISCLOSED UNDER PARAGRAPH (1) OF THIS SUBSECTION.".

AMENDMENT NO. 5

On page 4, in line 5, strike "OR" and substitute "<u>AND</u>"; in line 8, strike "FILES OR REPORTS" and substitute "<u>RECORDS</u>"; in the same line, strike "LOCAL"; in line 9, strike "OF SOCIAL SERVICES"; in line 10, after "REPORTER;" insert "<u>OR</u>"; in line 11, strike "NAMES OF THE SIBLINGS OF THE CHILD OR" and substitute "<u>THE NAME OF</u>"; in the same line, strike "OTHER"; and strike beginning with the semicolon in line 13 down through "SERVICES" in line 15.
