AMENDMENT NO. 1

On page 1, in line 14, strike "in certain fiscal years" and substitute "; providing that the Baltimore City Fire Department may submit a request for a grant or loan from the Volunteer Company Assistance Fund for certain purposes; requiring a certain amount from a certain surcharge to be paid to the District Court of Maryland for a certain purpose".

On page 2, in line 7, after "Fund" insert "; and 8-204(e)".

AMENDMENT NO. 2

On page 2 in line 31, on page 3 in line 4, and on page 4 in line 8, in each instance, strike "\$50" and substitute "\$7.50".

AMENDMENT NO. 3

On page 3, strike in their entirety lines 5 through 13, inclusive, and substitute:

- "(2) <u>SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION, THE SURCHARGES COLLECTED UNDER THIS SUBSECTION SHALL BE CREDITED AS</u> FOLLOWS:
- (I) 50% TO THE VOLUNTEER COMPANY ASSISTANCE FUND TO BE USED IN ACCORDANCE WITH THE PROVISIONS OF TITLE 8, SUBTITLE 2 OF THE PUBLIC SAFETY ARTICLE; AND
- (II) 50% TO THE STATE HELICOPTER REPLACEMENT FUND TO BE USED IN ACCORDANCE WITH THE PROVISIONS OF § 2-801 OF THE PUBLIC SAFETY ARTICLE.

AMENDMENT NO. 5

On page 4, after line 13, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That, notwithstanding any other provision of this Act, in fiscal year 2007, the first \$328,850 in surcharges collected under this Act shall be paid to the District Court of Maryland to pay its costs related to implementation of the surcharge required under this Act."
