16 17	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
18	Article - Education

20 21	(b) (1) The Commission shall coordinate the overall growth and development of postsecondary education in the State.
24	(2) (i) In consultation with the governing boards and agencies concerned with postsecondary education in the State, the Commission shall develop and periodically update an overall plan consistent with the Charter, known as the State Plan for Higher Education, that shall identify:
26	1. The present and future needs for postsecondary education

- 12.The present and future capabilities of the different2 institutions and segments of postsecondary education in the State; and
- 3 3. The long-range and short-range objectives and priorities

- 6 (ii) The Commission shall ensure that the State Plan for Higher 7 Education complies with the State's equal educational opportunity obligations under 8 State and federal law, including Title VI of the Civil Rights Act.
- 9 (iii) In developing the State Plan for Higher Education, the
- 10 Commission shall incorporate the goals and priorities for higher education identified
- 11 in this Division III and, for the University System of Maryland, including those
- 12 identified in §§ 10-209 and 12-106 of this article.
- 13(3)(i)The Commission shall submit to the Governor and, subject to §142-1246 of the State Government Article, to the General Assembly a [biennial]15QUADRENNIAL review of the plan by July 1, [1995] 2008 and by July 1 of each
- 16 [alternate] FOURTH year thereafter.
- 17 (ii) The [biennial] QUADRENNIAL review shall include a report on 18 the status and needs of postsecondary education in the State.

- 28 recognized for excellence in research and the advancement of knowledge.
- 29 (ii) With respect to the constituent institutions of the University
- 30 System of Maryland in the Baltimore region, the Commission shall direct the Board of
- 31 Regents of the University of Maryland to maintain and enhance a coordinated Higher
- 32 Education Center for Research and Graduate and Professional Study in the Baltimore33 area.
- (iii) With respect to Morgan State University, the Commission shall
  direct the Board of Regents of Morgan State University to develop and implement a
  plan for the enhancement of that institution as the State's public urban university
  with the appropriate programs, faculty, and facilities.

1 (7)The Commission has authority to approve regional higher education 2 centers to operate in the State and has statewide coordinating responsibility for 3 regional higher education centers. The Commission may distribute strategic incentive funds to an 4 (8)5 institution of higher education or a regional higher education center to encourage attainment of the goals and priorities set forth in the State Plan for Higher 6 7 Education. 8 11-302. 9 The president of each public institution of higher education is (a) (1)10 responsible for developing a mission statement. 11 (2)The president shall submit the mission statement to the institution's 12 governing board. 13 (3)Upon the direction of the governing board, the president shall update 14 the mission statement [at least] every 4 years IN THE YEAR IMMEDIATELY 15 FOLLOWING THE QUADRENNIAL REVIEW OF THE STATE PLAN FOR HIGHER 16 EDUCATION AS SET FORTH IN § 11-105 OF THIS TITLE. 17 (b) The governing board: (1)18 (i) Shall review the mission statement and may require the 19 president to prepare a revised mission statement; 20 (ii) May adopt the mission statement as submitted or with 21 amendments; and 22 (iii) Shall submit the statement to the Commission. 23 In the case of constituent institutions of the University System (2)(i) 24 of Maryland, the Chancellor of the University System of Maryland shall review the statement prior to its consideration by the Board of Regents and make 25 26 recommendations. 27 (ii) Before adopting the mission statements, the Board of Regents 28 shall review the statements individually and on a systemwide basis to assure that: They are consistent with the Charter and the systemwide 29 1. 30 plan; and 31 2. They will promote the efficient and effective use of the 32 institution's and System's resources. 33 (iii) The Board shall consolidate the statements into an adopted 34 systemwide statement.
