A BILL ENTITLED

1 AN ACT concerning

2 **Children's Trust Fund**

3 FOR the purpose of establishing a Children's Trust Fund and requiring that
4 allocations from the Fund be used for the Child Abuse and Neglect Centers of
5 Excellence Initiative; and generally relating to the Children's Trust Fund.

6 BY repealing and reenacting, with amendments,

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article - Health - General**

19 4-217.

20 (a) (3) (i) The Secretary shall provide on request, to any person
21 authorized by regulation adopted under this subtitle, a commemorative birth
22 certificate.

23 (ii) The Department shall set a fee for the commemorative birth
24 certificate.

25 (iii) The commemorative birth certificate shall:

1 1. Be in a form consistent with the need to protect the
2 integrity of vital records but suitable for display; and

3 2. Have the same status as evidence as the original birth
4 certificate.

5 (iv) [Funds] A PORTION OF THE FUNDS COLLECTED UNDER THIS
6 PARAGRAPH SHALL GO TO THE DEPARTMENT FOR THE PRODUCTION COSTS OF
7 ISSUING THE COMMEMORATIVE BIRTH CERTIFICATES. THE REMAINDER OF THE
8 FUNDS collected [under this paragraph] shall be paid into the Children's Trust Fund
9 ESTABLISHED UNDER § 13-2207 OF THIS ARTICLE TO PROVIDE FUNDING FOR THE
10 CHILD ABUSE AND NEGLECT CENTERS OF EXCELLENCE INITIATIVE.

11 (v) The Secretary shall adopt regulations to implement the
12 provisions of this paragraph.

13 13-2207.

14 (A) IN THIS SECTION, "FUND" MEANS THE CHILDREN'S TRUST FUND.

15 (B) THERE IS A CHILDREN'S TRUST FUND.

16 (C) THE PURPOSE OF THE FUND IS TO PROVIDE FUNDING FOR THE CHILD
17 ABUSE AND NEGLECT CENTERS OF EXCELLENCE INITIATIVE.

18 (D) THE DEPARTMENT SHALL ADMINISTER THE FUND.

19 (E) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT SUBJECT TO §
20 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

21 (F) THE FUND CONSISTS OF:

22 (1) FEES DISTRIBUTED TO THE FUND FROM THE ISSUANCE OF
23 COMMEMORATIVE BIRTH CERTIFICATES UNDER § 4-217(A)(3) OF THIS ARTICLE;

24 (2) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND; AND

25 (3) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR THE
26 BENEFIT OF THE FUND.

27 (G) THE TREASURER SHALL HOLD THE FUND SEPARATELY, AND THE
28 COMPTROLLER SHALL ACCOUNT FOR THE FUND.

29 (H) THE TREASURER SHALL INVEST AND REINVEST THE MONEY OF THE FUND
30 IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

31 (I) (1) THE COMPTROLLER SHALL PAY OUT MONEY FROM THE FUND AS
32 DIRECTED BY THE SECRETARY.

33 (2) NO PART OF THE FUND MAY REVERT OR BE CREDITED TO:

1 (I) THE GENERAL FUND OF THE STATE; OR

2 (II) ANY OTHER SPECIAL FUND OF THE STATE.

3 (J) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE
4 WITH THE STATE BUDGET.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
6 effect July 1, 2006.
