BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 16 MARYLAND, That the Laws of Maryland read as follows: **Article - Business Occupations and Professions** 17 18 4-506.1. THE BOARD MAY REINSTATE A BARBERSHOP PERMIT THAT HAS EXPIRED 19 (A) 20 IF THE OWNER OF THE BARBERSHOP:

- 1 (1) APPLIES TO THE BOARD FOR REINSTATEMENT WITHIN 45 DAYS 2 AFTER THE PERMIT EXPIRES:
- 3 (2) OTHERWISE MEETS THE REQUIREMENTS OF § 4-506(C) OF THIS 4 SUBTITLE; AND
- 5 (3) PAYS TO THE BOARD A REINSTATEMENT FEE ESTABLISHED BY THE 6 BOARD IN ACCORDANCE WITH § 4-206 OF THIS TITLE, IN ADDITION TO THE RENEWAL
- 7 FEE REQUIRED UNDER § 4-506(C)(2) OF THIS SUBTITLE.
- 8 (B) IF AN OWNER OF A BARBERSHOP HAS FAILED TO RENEW A BARBERSHOP
- 9 PERMIT AND APPLIES TO THE BOARD FOR REINSTATEMENT MORE THAN 45 DAYS
- 10 AFTER THE PERMIT HAS EXPIRED. THE BOARD SHALL REINSTATE THE PERMIT ONLY
- 11 IF THE BARBERSHOP OWNER QUALIFIES FOR A BARBERSHOP PERMIT IN

- 23 (B) IF AN OWNER OF A SALON HAS FAILED TO RENEW A BEAUTY SALON
- 24 PERMIT AND APPLIES TO THE BOARD FOR REINSTATEMENT MORE THAN 45 DAYS
- 25 AFTER THE PERMIT HAS EXPIRED, THE BOARD SHALL REINSTATE THE PERMIT ONLY
- 26 IF THE SALON OWNER QUALIFIES FOR A BEAUTY SALON PERMIT IN ACCORDANCE
- 27 WITH §§ 5-502 AND 5-503 OF THIS SUBTITLE.
