BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 15 MARYLAND, That the Laws of Maryland read as follows: 16 **Article 2B - Alcoholic Beverages** 17 15-109. In Caroline County: 18 (g) 19 (1)[The chairman shall receive an annual salary of \$1,750 and the two 20 associate members shall each receive an annual salary of \$1,500. The substitute 21 member of the Board shall receive \$50 for each day employed in the actual discharge 22 of official duties.] THE MEMBERS OF THE BOARD OF LICENSE COMMISSIONERS 23 SHALL RECEIVE ANNUAL SALARIES AS DETERMINED BY THE COUNTY 24 COMMISSIONERS, BUT NOT LESS THAN:

- 25 (I) \$3,000 FOR THE CHAIRMAN; AND
- 26 (II) \$2,500 FOR A REGULAR BOARD MEMBER.

1(2)THE ALTERNATE MEMBER OF THE BOARD SHALL RECEIVE \$100 PER2MEETING BUT NOT MORE THAN \$2,000 IN ANY 1-YEAR PERIOD.

3 [(2)] (3) The chairman, associate members and substitute member shall 4 be reimbursed for expenses incurred in the performance of their duties in accordance 5 with the Standard State Travel Regulations.

6 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §

7 35 of the Maryland Constitution, this Act may not be construed to extend or apply to

 $8\;$ the salary or compensation of the chairman, regular members, or alternate member of

 $9\;$ the Board of License Commissioners of Caroline County in office on the effective date

10 of this Act, but the provisions of this Act concerning the salary or compensation of the

11 chairman, regular members, or alternate member of the Board of License

12 Commissioners of Caroline County shall take effect at the beginning of the next

13 following term of office.

14 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 15 July 1, 2006.
