21 22	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

25 26	(a) (1) In this section and §§ 3-605 and 3-606 of this subtitle the following words have the meanings indicated.
27 28	(3) "Caregiver" means a person under a duty to care for a vulnerable adult because of a contractual undertaking to provide care.

1 "Vulnerable adult" means an adult who lacks the physical or mental (10)2 capacity to provide for the adult's daily needs. 3 8-301. A person may not knowingly, willfully, and with fraudulent intent possess, 4 (b) 5 obtain, or help another to possess or obtain any personal identifying information of an 6 individual, without the consent of the individual, in order to use, sell, or transfer the information to get a benefit, credit, good, service, or other thing of value in the name 8 of the individual. 9 A person may not knowingly and willfully assume the identity of another: (c) 10 (1) to avoid identification, apprehension, or prosecution for a crime; or 11 (2) with fraudulent intent to: 12 get a benefit, credit, good, service, or other thing of value; or (i) 13 (ii) avoid the payment of debt or other legal obligation. 14 (d) (1) A person who violates this section where the benefit, credit, good, service, or other thing of value that is the subject of subsection (b) or (c) of this section 15 has a value of \$500 or greater is guilty of a felony and on conviction is subject to imprisonment not exceeding 5 years or a fine not exceeding \$25,000 or both. 18 A person who violates this section where the benefit, credit, good, 19 service, or other thing of value that is the subject of subsection (b) or (c) of this section 20 has a value of less than \$500 is guilty of a misdemeanor and on conviction is subject to imprisonment not exceeding 18 months or a fine not exceeding \$5,000 or both. 22 A person who violates this section under circumstances that 23 reasonably indicate that the person's intent was to manufacture, distribute, or dispense another individual's personal identifying information without that individual's consent is guilty of a felony and on conviction is subject to imprisonment not exceeding 5 years or a fine not exceeding \$25,000 or both. 27 A person who violates subsection (c)(1) of this section is guilty of a 28 misdemeanor and on conviction is subject to imprisonment not exceeding 18 months 29 or a fine not exceeding \$5,000 or both. 30 When the violation of this section is pursuant to one scheme or (5) 31 continuing course of conduct, whether from the same or several sources, the conduct 32 may be considered as one violation and the value of the benefit, credit, good, service, 33 or other thing of value may be aggregated in determining whether the violation is a 34 felony or misdemeanor.
