The surviving minor child or dependent parent of a State Police officer who 4 (c) 5 died while employed by the State may enroll and participate in the health insurance 6 benefit options established under the Program as long as the child or parent is 7 receiving an allowance under Title 29, Subtitle 2 of this article.
