1 AN ACT concerning

2 **Election Law - Worcester County Democratic Party Central Committee**

3 FOR the purpose of specifying the membership of the Worcester County Democratic
4 Party Central Committee; staggering the terms of the members of the Central
5 Committee; and generally relating to the membership and terms of the
6 Worcester County Democratic Party Central Committee.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

1 **Article - Election Law**

2 4-202.

3 (f) (1) Except as provided in paragraph (2) of this subsection, the tenure in
4 office of a member of the central committee of any political party shall:

5 (i) begin at the time the results of that election are certified; and

6 (ii) continue to the extent of any extension in time between primary
7 elections by reason of any change in the date of holding primary elections by a
8 political party in the State.9 (2) The tenure in office of a member of the Republican Party Central
10 Committee shall begin on the 14th day following the gubernatorial general election.11 (3) For purposes of this subsection, upon relinquishing residency in the
12 county, a member of a party central committee shall be considered to have resigned.

14 (H) (1) IN WORCESTER COUNTY, THE DEMOCRATIC PARTY CENTRAL
15 COMMITTEE CONSISTS OF 11 MEMBERS AS FOLLOWS:16 (I) SEVEN MEMBERS WHO SHALL RESIDE IN AND BE ELECTED,
17 RESPECTIVELY, BY THE ELIGIBLE VOTERS OF EACH OF THE SEVEN COUNTY
18 COMMISSIONER DISTRICTS; AND19 (II) FOUR MEMBERS WHO SHALL RESIDE IN WORCESTER COUNTY,
20 BE ELECTED AT LARGE BY THE ELIGIBLE VOTERS OF THE ENTIRE COUNTY, AND
21 RECEIVE THE HIGHEST NUMBER OF VOTES CAST FOR CANDIDATES IN THE AT LARGE
22 ELECTION.23 (2) (I) A CANDIDATE FOR ELECTION TO THE DEMOCRATIC PARTY
24 CENTRAL COMMITTEE SHALL DECLARE AT THE TIME OF FILING A CERTIFICATE OF
25 CANDIDACY WHICH SEAT THE CANDIDATE IS SEEKING.26 (II) A MEMBER ELECTED TO REPRESENT A SPECIFIC COUNTY
27 COMMISSIONER DISTRICT WHO CEASES TO RESIDE IN THAT DISTRICT MAY NOT
28 CONTINUE TO SERVE ON THE CENTRAL COMMITTEE.29 (3) ANY VACANCY IN A SEAT ON THE CENTRAL COMMITTEE HELD BY AN
30 INDIVIDUAL ELECTED FROM A COUNTY COMMISSIONER DISTRICT SHALL BE FILLED
31 BY AN INDIVIDUAL WHO RESIDES IN THAT DISTRICT.32 SECTION 2. AND BE IT FURTHER ENACTED, That, subject to § 4-202(f) of
33 the Election Law Article, the terms of the members of the Worcester County
34 Democratic Party Central Committee elected under this Act shall expire as follows:

1 (1) the term of the member elected at the November 2006 election from
2 county commissioner district 1, ~~3, 5, 4, 6,~~ and 7 shall expire after the November 2010
3 election, and then expire each four years thereafter;

4 (2) the term of the member elected at the November 2006 election from
5 county commissioner district 2, ~~4, and 6~~ 3, and 5 shall expire after the November 2008
6 election, and then expire each four years thereafter; and

7 (3) (i) the term of each of the two members elected from the county at
8 large at the November 2006 election who receive the highest and second highest
9 number of votes cast at that election shall expire after the November 2010 election,
10 and then expire each four years thereafter; and

11 (ii) the term of each of the two members elected from the county at
12 large at the November 2006 election who receive the third and fourth highest number
13 of votes cast at that election shall expire after the November 2008 election, and then
14 expire each four years thereafter.

15 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 June 1, 2006.
