3 FOR the purpose of increasing the annual salary of the Sheriff of Baltimore County

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

13 MARYLAND, That the Laws of Maryland read as follows:

14 Article - Courts and Judicial Proceedings

15 2-309.

16 (e) (1) The Sheriff of Baltimore County shall receive [a salary of not more 17 than \$70,000.] AN ANNUAL SALARY OF:

- 18 (I) \$75,000 FOR CALENDAR YEAR 2007;
- 19 (II) \$80,000 FOR CALENDAR YEAR 2008;

(III) \$85,000 FOR CALENDAR YEAR 2009; AND

4 The Sheriff shall appoint an under-sheriff and any number of (2)5 deputies and any clerical assistant required by the duties of the office. The Sheriff 6 may also appoint a number of deputies to the ranks of chief deputy, captain, 7 lieutenant, and sergeant as his duties and responsibilities require. The cost and 8 expense of these supervisory, administrative, and clerical positions, including 9 salaries, shall be as provided in the budget of the county by the County Executive and 10 as approved by the County Council. All full-time employees under this subsection are 11 subject to the provisions of the county merit system and the rules and regulations 12 passed by the County Council pursuant to the charter, as to qualifications, 13 compensation, and other regulations. Part-time deputies may not be employed by the 14 Sheriff's office. However, the Sheriff may appoint as part-time deputies persons 15 employed in specific plants, institutions, colleges, and hospitals situated within 16 Baltimore County who are limited to service only within the particular facility where 17 they are employed, and who may not be compensated by Baltimore County for their 18 services.

SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to 1 the salary or compensation of the Sheriff of Baltimore County in office on the effective date of this Act, but the provisions of this Act concerning the salary or compensation 3 of the Sheriff of Baltimore County shall take effect at the beginning of the next 4 following term of office.

25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 26 October 1, 2006.
