- 3 A. The County Commissioners shall meet in regular session 1 day each week
- 4 and shall remain in session as long as necessary for the completion of
- 5 pending business.
- 6 B. The County Commissioners shall give reasonable advance notice of County
- 7 Commissioner sessions.
- 8 C. The County Commissioners shall spend 1 day each week in the offices of
- 9 the County Commissioners to carry out administrative functions.
