- 3 FOR the purpose of creating in Cecil County a wine festival alcoholic beverages
- 4 license; providing for the terms and conditions of the license; requiring an
- 5 applicant for a wine festival license to be a holder of a certain alcoholic
- 6 beverages license; requiring the Cecil County Liquor Board to assure that the
- 7 primary focus of the festival is the promotion of Maryland wine; requiring the
- 8 holder of a wine festival license to display and sell certain wine; providing for a
- 9 license fee; allowing the wine festival license holder from holding another
- alcoholic beverages license of a different class or nature; authorizing the Board
- to choose a festival date; requiring the Board to choose a certain festival
- location; requiring the Board to adopt certain regulations; defining a certain
- term; and generally relating to alcoholic beverages in Cecil County.

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 20 MARYLAND, That the Laws of Maryland read as follows:
- 21 Article 2B Alcoholic Beverages
- 22 8-306.1.
- 23 (A) IN THIS SECTION, "BOARD" MEANS THE CECIL COUNTY LIQUOR BOARD.

- 1 (B) THIS SECTION APPLIES ONLY IN CECIL COUNTY.
- 2 (C) THE BOARD MAY ISSUE A SPECIAL WINE FESTIVAL (WF) LICENSE.
- 3 (D) AN APPLICANT FOR A SPECIAL WF LICENSE SHALL BE A HOLDER OF A
- 4 STATE RETAIL ALCOHOLIC BEVERAGES LICENSE, STATE CLASS 3 WINERY LICENSE,
- 5 OR STATE CLASS 4 WINERY LICENSE.
- 6 (E) (1) THE BOARD SHALL ASSURE THAT THE PRIMARY FOCUS OF THE 7 FESTIVAL IS THE PROMOTION OF MARYLAND WINE.
- 8 (2) THE HOLDER OF A SPECIAL WF LICENSE SHALL DISPLAY AND SELL 9 WINE THAT IS:
- 10 (I) PRICE FILED IN ACCORDANCE WITH REGULATIONS ADOPTED 11 BY THE COMPTROLLER; AND
- 12 (II) DISTRIBUTED IN THE STATE.
- 13 (F) A SPECIAL WF LICENSE ENTITLES THE HOLDER TO DISPLAY AND SELL AT
- 14 RETAIL WINE FOR CONSUMPTION ON OR OFF THE LICENSED PREMISES ON THE DAYS
- 15 AND FOR THE HOURS DESIGNATED FOR THE WINE FESTIVAL IN THE COUNTY.
- 16 (G) THE LICENSE FEE IS \$20.
- 17 (H) THIS SECTION DOES NOT PROHIBIT THE LICENSE HOLDER FROM
- 18 HOLDING ANOTHER ALCOHOLIC BEVERAGES LICENSE OF A DIFFERENT CLASS OR
- 19 NATURE.
- 20 (I) THE BOARD:
- 21 (1) MAY CHOOSE ONE WEEKEND ANNUALLY DURING THE MONTHS OF
- 22 JUNE, JULY, AUGUST, OR SEPTEMBER FOR THE WINE FESTIVAL THAT DOES NOT
- 23 CONFLICT WITH THE ANNE ARUNDEL COUNTY BEER AND WINE FESTIVAL, THE
- 24 CUMBERLAND AND SHENANDOAH VALLEY WINE FESTIVAL, OR THE MARYLAND WINE
- 25 FESTIVAL; AND
- 26 (2) SHALL CHOOSE A LOCATION IN THE COUNTY FOR THE FESTIVAL
- 27 THAT IS NOT LICENSED UNDER THIS ARTICLE.
- 28 (J) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS SECTION.
- 29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 30 July 1, 2006.
