BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 15 MARYLAND, That the Laws of Maryland read as follows: **Article - State Government** 16 17 9-120. The Comptroller shall distribute the State Lottery Fund to pay: 18 (a) 19 on a pro rata basis for the daily and nondaily State lottery games, the 20 expenses of administering and operating the State lottery, as authorized under this 21 subtitle and the State budget; and 22 then, except as provided in § 10-113.1 of the Family Law Article and (2) 23 § 11-618 of the Criminal Procedure Article, the holder of each winning ticket or share.
