3 FOR the purpose of requiring a condemnor that decides to sell the condemned

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

16 MARYLAND, That the Laws of Maryland read as follows:

Article - Real Property

18 12-108.1.

(A) FOR A PROPERTY CONDEMNED IN ACCORDANCE WITH THIS TITLE, IF AT
20 ANY TIME THE PLAINTIFF THAT ACQUIRED THE PROPERTY DECIDES TO SELL THE
21 PROPERTY, THE PLAINTIFF SHALL FIRST MAKE AN OFFER IN WRITING TO THE
22 DEFENDANT FROM WHOM THE PROPERTY WAS ACQUIRED OR THE HEIRS OR
23 ASSIGNEES OF THE DEFENDANT.

(B) THE SALES PRICE FOR THE CONDEMNED PROPERTY SHALL BE THE
AMOUNT OF THE AWARD OF COMPENSATION PAID FOR THE PROPERTY, REGARDLESS
OF ANY IMPROVEMENTS MADE ON THE PROPERTY AFTER CONDEMNATION.

1 (C) (1) THE DEFENDANT OR THE HEIRS OR ASSIGNEES OF THE DEFENDANT 2 HAVE THE RIGHT TO REPURCHASE THE CONDEMNED PROPERTY WITHIN 90 DAYS 3 AFTER THE DATE OF THE WRITTEN OFFER.

4 (2) IF THE DEFENDANT OR THE HEIRS OR ASSIGNEES OF THE
5 DEFENDANT DO NOT ACCEPT THE OFFER OF SALE WITHIN THE TIME PERIOD
6 DESCRIBED IN PARAGRAPH (1) OF THIS SUBSECTION, THE PLAINTIFF MAY SELL THE
7 PROPERTY TO ANY OTHER PERSON IN ACCORDANCE WITH PROCEDURES
