BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 MARYLAND, That the Laws of Maryland read as follows: **Article - Courts and Judicial Proceedings** 17 7-202. [The] EXCEPT AS PROVIDED IN SUBSECTION (F) OF THIS SECTION, (a) (1)19 THE State Court Administrator shall determine the amount of all court costs and 20 charges for the circuit courts of the counties with the approval of the Board of Public 21 Works. The fees and charges shall be uniform throughout the State. The Comptroller of the State shall require clerks of court to collect all (2)23 fees required to be collected by law. (b) The clerk may not charge the State, any county, municipality, or Baltimore 25 City any fee provided by this subtitle, unless the State, county, municipality, or 26 Baltimore City first gives its consent.

(c) The clerk is entitled to a reasonable fee for performing any other service
 that is not enumerated in this subtitle or in §§ 3-601 through 3-603 of the Real
 Property Article.

4 (d) The State Court Administrator, as part of the Administrator's 5 determination of the amount of court costs and charges in civil cases, shall assess a 6 surcharge that:

7 (1) May not be more than \$25 per case; and

8 (2) Shall be deposited into the Maryland Legal Services Corporation
9 Fund established under § 7-408 of this title.

16 (II) EACH MONTH, SHALL PAY THE PROCEEDS FROM THE FEES TO 17 THE BOARD OF COUNTY COMMISSIONERS.

18 (2) THE BOARD OF COUNTY COMMISSIONERS SHALL DISTRIBUTE THE 19 PROCEEDS EQUALLY TO HEARTLY HOUSE, INC. AND THE CHILD ADVOCACY CENTER 20 OF FREDERICK COUNTY.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 22 October 1, 2006.
