## A BILL ENTITLED

## 1 AN ACT concerning

## 2 Creation of a State Debt - Charles County - Mattawoman Creek Art Center

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$15,000, the
- 4 proceeds to be used as a grant to the Board of Directors of the Mattawoman
- 5 Creek Art Center, Inc. for certain development or improvement purposes;
- 6 providing for disbursement of the loan proceeds, subject to a requirement that
- 7 the grantee provide and expend a matching fund; requiring the grantee to grant
- 8 and convey a certain easement to the Maryland Historical Trust; establishing a
- 9 deadline for the encumbrance or expenditure of the loan proceeds; and providing
- generally for the issuance and sale of bonds evidencing the loan.

## 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 12 MARYLAND, That:
- 13 (1) The Board of Public Works may borrow money and incur indebtedness on
- 14 behalf of the State of Maryland through a State loan to be known as the Charles
- 15 County Mattawoman Creek Art Center Loan of 2006 in a total principal amount
- 16 equal to the lesser of (i) \$15,000 or (ii) the amount of the matching fund provided in
- 17 accordance with Section 1(5) below. This loan shall be evidenced by the issuance, sale,
- 18 and delivery of State general obligation bonds authorized by a resolution of the Board
- 19 of Public Works and issued, sold, and delivered in accordance with §§ 8-117 through
- 20 8-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 21 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 22 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 23 § 8-122 of the State Finance and Procurement Article.
- 24 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 25 and first shall be applied to the payment of the expenses of issuing, selling, and
- 26 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 27 shall be credited on the books of the Comptroller and expended, on approval by the
- 28 Board of Public Works, for the following public purposes, including any applicable
- 29 architects' and engineers' fees: as a grant to the Board of Directors of the
- 30 Mattawoman Creek Art Center, Inc. (referred to hereafter in this Act as "the grantee")
- 31 for the planning, design, and construction of road paving improvements, for the
- 32 renovation, repair, reconstruction, and capital equipping of improvements to the

- 1 bathroom, and for the capital equipping and installation of security lights, safety
- 2 rails, and signage at the Mattawoman Creek Art Center, located in Marbury.
- 3 (4) An annual State tax is imposed on all assessable property in the State in
- 4 rate and amount sufficient to pay the principal of and interest on the bonds as and
- 5 when due and until paid in full. The principal shall be discharged within 15 years
- 6 after the date of issuance of the bonds.
- 7 (5) Prior to the payment of any funds under the provisions of this Act for the
- 8 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 9 matching fund. No part of the grantee's matching fund may be provided, either
- 10 directly or indirectly, from funds of the State, whether appropriated or
- 11 unappropriated. No part of the fund may consist of real property or funds expended
- 12 prior to the effective date of this Act. The fund may consist of in kind contributions. In
- 13 case of any dispute as to the amount of the matching fund or what money or assets
- 14 may qualify as matching funds, the Board of Public Works shall determine the matter
- 15 and the Board's decision is final. The grantee has until June 1, 2008, to present
- 16 evidence satisfactory to the Board of Public Works that a matching fund will be
- 17 provided. If satisfactory evidence is presented, the Board shall certify this fact and
- 18 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
- 19 equal to the amount of the matching fund shall be expended for the purposes provided
- 20 in this Act. Any amount of the loan in excess of the amount of the matching fund
- 21 certified by the Board of Public Works shall be canceled and be of no further effect.
- 22 (6) (a) Prior to the issuance of the bonds, the grantee shall grant and convey
- 23 to the Maryland Historical Trust a perpetual preservation easement to the extent of
- 24 its interest:
- 25 (i) On the land or such portion of the land acceptable to the Trust;
- 26 and
- 27 (ii) On the exterior and interior, where appropriate, of the historic
- 28 structures.
- 29 (b) If the grantee or beneficiary of the grant holds a lease on the land
- 30 and structures, the Trust may accept an easement on the leasehold interest.
- 31 (c) The easement must be in form and substance acceptable to the Trust
- 32 and any liens or encumbrances against the land or the structures must be acceptable
- 33 to the Trust.
- 34 (7) The proceeds of the loan must be expended or encumbered by the Board of
- 35 Public Works for the purposes provided in this Act no later than June 1, 2013. If any
- 36 funds authorized by this Act remain unexpended or unencumbered after June 1,
- 37 2013, the amount of the unencumbered or unexpended authorization shall be
- 38 canceled and be of no further effect. If bonds have been issued for the loan, the
- 39 amount of unexpended or unencumbered bond proceeds shall be disposed of as
- 40 provided in § 8-129 of the State Finance and Procurement Article.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 2 June 1, 2006.
