2 Creation of a State Debt - Baltimore County - Todd's Inheritance

- 3 FOR the purpose of authorizing the creation of a State Debt in the amount of

- 12 (1) The Board of Public Works may borrow money and incur indebtedness on
- 13 behalf of the State of Maryland through a State loan to be known as the Baltimore
- 14 County Todd's Inheritance Loan of 2006 in the total principal amount of \$700,000.
- 15 This loan shall be evidenced by the issuance, sale, and delivery of State general
- 16 obligation bonds authorized by a resolution of the Board of Public Works and issued,
- 17 sold, and delivered in accordance with §§ 8-117 through 8-124 of the State Finance
- 18 and Procurement Article and Article 31, § 22 of the Code.
- 19 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 20 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 21 § 8-122 of the State Finance and Procurement Article.
- 22 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer

The principal shall be discharged within 15 years 2 after the date of issuance of the bonds. 3 (a) Prior to the issuance of the bonds, the grantee shall grant and convey 4 to the Maryland Historical Trust a perpetual preservation easement to the extent of 5 its interest: On the land or such portion of the land acceptable to the Trust; 6 (i) 7 and 8 (ii) On the exterior and interior, where appropriate, of the historic structures. 9 10 (b) If the grantee or beneficiary of the grant holds a lease on the land 11 and structures, the Trust may accept an easement on the leasehold interest. 12 (c) The easement must be in form and substance acceptable to the Trust 13 and any liens or encumbrances against the land or the structures must be acceptable 14 to the Trust. 15 (6)The proceeds of the loan must be expended or encumbered by the Board of 16 Public Works for the purposes provided in this Act no later than June 1, 2013.
